Further search of S1 and the area of which he was seated revealed a small amount of methamphetamine, heroin, and multiple prescription pills. S1 was arrested in reference to possession of a firearm by a convicted felon, possession of ammunition by a convicted felon, carrying a concealed firearm, possession of methamphetamine, possession of heroin, possession of a controlled substance, possession of a legend drug, possession of drug paraphernalia, and resisting an officer without violence.
