V1 had marks on her neck consistent with strangulation, and S1 left in V1's vehicle without her permission. Reckless Driver	20-54279	I95 NB MM 281	Deputy Gaddie and Deputy McCarthy were conducting proactive enforcement on I95 when they observed a black Nissan Murano at a high rate of speed. Sergeant Weaver observed the vehicle on E State Road 100 and upon attempting to stop the vehicle it fled Northbound on Belle Terre Parkway. Deputy Malta and Deputy Denker successfully deployed stop sticks on the vehicle which fled Northbound into St Johns County. SJSO assisted and arrested 2 subjects from the vehicle on A1A. The driver S1 had a warrant for his arrest out of Broward County for resisting arrest without violence, trespassing in a structure and additional pickup orders on file. He was additionally charged for no valid driver's license, providing false name while detained, resisting without violence and aggravated fleeing and eluding and the passenger S2 had a warrant for his arrest out of Broward County for violation of probation reference burglary.
