Robbery	19-64343	Hernandez Ave	V1 walked to the Circle K at 5484 N A1A to report a robbery. V1 reported S1 "hogtied" him, also wrapping the cord around his neck restricting his breathing. S1 then punched him and stomped on him while he was tied up. S1 then untied V1 and V1 walked to the Circle K. Charges are being completed for kidnapping, robbery, aggravated battery, and grand theft. Several subjects exited the residence including S1 who was taken into custody. Report by Deputy Capela.
Assist Other Agency (Shooting)	19-64283	US1	VCSO advised that they were pursuing a maroon Challenger Northbound on US1 towards Flagler County that was the suspect vehicle in a shooting and the occupants were armed. VCSO advised the suspects bailed from the car at St Mary's Church on Old Dixie Highway and got into a silver Audi and fled back towards US1. FCSO then engaged in the pursuit as it reentered Volusia County and they took back over the pursuit. DBPD requested the vehicle be towed to FCSO impound yard. TS (Warrant Service)	19-64306	Walnut Avenue	Deputy Prevatt attempted a traffic stop on a motor home which continued driving to 6620 Walnut Avenue where the driver fled on foot from the vehicle up the driveway. Registered Owner of the vehicle, S1, had a warrant for aggravated assault with a deadly weapon and fleeing and eluding and whose vehicle previously fled from a traffic stop on 6-5-19 from Bunnell to the Mondex. A perimeter was established and AirOne and K9 responded but were unable to locate the male. Corporal Meehan and Deputy Lichty later observed S1 walking back onto the property through the woods and enter into a green Dodge Ram. They attempted to stop the truck at which point it rammed through the gate at the residence and fled down Water Oak Road. Deputy Prevatt located the vehicle and a pursuit was authorized by Sergeant Weaver due to the forcible felony warrant for S1. Deputy Prevatt pursued the vehicle down Water Oak Road where the suspect vehicle struck a citizen's vehicle (no reported injuries). The vehicle continued to Mahogany Boulevard where Corporal Meehan's push bumper struck the back of the truck causing minor damage to his patrol vehicle. Deputy Gomez had a positive stop stick deployment at the Country Store. S1 eventually fled on foot from the vehicle behind 4489 Clove Avenue and was apprehended with a Taser deployment by Deputy Lichty and Deputy Prevatt. S1 was charged with aggravated fleeing and eluding x 2, DWLS, resisting without violence, reckless driving and leaving the scene of a crash with property damage. Report by Deputy Prevatt.
