Stolen Vehicle Recovered	19-72581	Ulong Place	FCSO located the stolen black Charger at USHY1 and County Road 304. The stolen vehicle was followed until units were set up with stop sticks. The vehicle was lost in the area of Citation Parkway. A citizen called in that the vehicle crashed in the woods at the intersection of Seminole Woods Boulevard and Ulaturn Trail and two suspects were observed running south into the wood line. S1 and S2 were arrested. S1 was charged with loitering and prowling, possession of methamphetamine, credit card fraud, resisting an officer without violence, possession of drug paraphernalia and felony VOP. Jimmie S2 was charged with grand theft of an automobile, felony DWLS with knowledge, aggravated fleeing and eluding, loitering and prowling, resisting an officer without violence and felony VOP. S3 was charged with obstruction of justice and accessory after the fact as she drove to the area in an attempt to aid the suspect flee and avoid arrest.
Stolen Vehicle	19-72735	Palm Coast Parkway South East	V1 has requested S1 to return his vehicle multiple times via Facebook messenger and S1 has so far refused to return the vehicle after advising that he would return it. Charges completed on S1 for grand theft of an automobile.
Burglary Residential	19-72773	Front Street	S1 came uninvited to the above address to see a male, Robert Ross, whom she dated previously, but no longer. When S1 arrived she parked away from the home to approach undetected. S1 then removed several screens before breaking the screen to the back porch, unlocking the door and entering the home through the unlocked master bedroom slider. Once in the home S1 hid in the closet for approximately 10 minutes before she was discovered by V1. S1 was arrested in reference to burglary, criminal mischief and possession of Suboxone.
Physical Disturbance	19-72725	Buttonworth Drive	S1 accused V1 of taking his money and punched her in the face several times causing her to bleed profusely and be transported to the hospital. S1 was arrested in reference to battery.
Missing Person Recovered	19-72719	Berkshire Lane	M1 was entered as a Silver Alert and found by SJSO. M1 did not meet Baker Act criteria and his son was advised to go pick him up. Approximately 2 hours after he was found M1 was observed driving around in circles by Kohls and McDonalds in sector 215. FCSO made contact with M1 and he advised his son never went to pick him up and told him to drive home. M1 apparently was released by

			SJSO to drive home by himself after he was entered as a Silver Alert.
Burglary Residential	19-72750	Berrybush Street	V1 reported that between 08-04-2019 at 10pm and 08-05-2019 at 8:00 am someone entered her residence and stole approximately \$100 from her purse.
