Domestic Disturbance -Physical	19-85211	Ponderosa Ln	RP stated she and her husband are currently going through a divorce, but still residing in the home together. Victim advised tonight she and S1 were involved in a verbal disturbance, when S1 grabbed her by the arms and forcefully pushed her onto the bed. She advised S1 then pulled the bedroom door off the hinges and threatened to hit her with it. The victim stated that S1 then went to another room, and she heard a "clicking" sound. When she walked out of the bedroom, the victim advised S1 was standing in the hallway holding a shotgun and he stated "Don't make me spend the rest of my life in prison". The victim stated this gave her a well founded fear that S1 may use the shotgun on her. She then left the residence and got a hotel room. Contact was then made with S1, who stated the altercation was only verbal and no violence or

threats of violence had occurred. The victim had visible bruising on her arms, conclusive with being forcefully grabbed. S1 was placed under arrest reference Battery-DV and Agg. Assault-DV and transported to FCIF. Report by DS Oldham
