Scott stated they had been in a verbal altercation a few days prior and when he went to confront Jesse about the matter, Jesse started violently shoving him into the black iron gate of Bulow's community pool. Scott explained Jesse came up behind him, shoving his driver's door closed, while repeatedly pushing him up against the car. RP waited 3 hours to report the incident and the exact address for the suspect is unknown at this time. Follow up will be done in an attempt to speak to the other party and determine charges. Once there, V1 exited his residence and S1 struck him in the face with what appeared to be a beer bottle causing bruising and glass to get stuck in his face. S1 then left the residence in his white 2001 Dodge Neon bearing Florida tag Z362I, but has not been located at this time, and is believed to possibly be in Volusia County. Charges for aggravated battery.

86749-18	Violation of Injunction	Claymont Ct S	Due to s1 going to the residence, he violated an injunction where he is the respondent with o1 being the petitioner. O1 is also the reporting party for the above disturbance but was not on scene.
86742-18	Disturbance Physical	Cypress Edge Dr (Steak N Shake)	S1 was traveling from North Carolina to Fort Lauderdale with her friends and stopped at Steak N Shake to order food. S1 became upset while she was waiting in the drive thru for her food and went inside the business demanding her food immediately while banging on the counter. S1 then demanded a refund, grabbed the register and threw it on the floor cracking the screen and causing extensive damage. Customers tried to calm her down but she then began physically striking two people. S1 was placed under arrest for Felony Criminal Mischief, two counts of battery, and disorderly conduct.
86659-18	Missing Person Found (Juvenile)	Old Kings Rd N (Wendy's)	M1 was entered missing out of Volusia. Mother called in advising she was at Wendy's. Upon arrival of Law Enforcement, the female fled on foot but was eventually located.
