Stolen Vehicle	18-90532	Lago Vista Dr	V1 stated her 2007 Honda Accord bearing FL tag Z76CBF (VIN #JHMCM563X7C011255) was stolen from her driveway sometime between 3PM and 9PM on today's date. V1 stated she left the keys in the vehicle and the vehicle was unlocked. Vehicle, tag, and decal entered stolen in FCIC/NCIC.		
Disturbance- Domestic	18-90597	Reid Place	Deputies responded to the above address in reference to a physical disturbance. Upon arrival, the male S1 ran from the rear of the house and tried to hide in the bushes, but was located and secured. Contact was made with his wife V1 who stated that she was trying to leave the residence, to go stay with family, but S1 would not let her leave. He continuously blocked the door and when she made it out , he grabbed her arm and pulled her back in. S1 attempted to grab her neck several times, but she was able to block that. S1 was arrested for Battery (domestic) and False Imprisonment.		
Disturbance- Domestic	18-90611	Powder Horn Dr.	O1 and O2 were involved in a verbal disturbance reference the power in their home being turned off. O2 called law enforcement to "calm O1 down" and both parties advised there were no threats of violence made by either party. Both subjects advised they would stay away from each other for the remainder of the night.

After being released, S1 contacted V1 multiple time through text messages, thus violating the judge's order for no contact. A charging affidavit was completed and forwarded to the SAO.

Disturbance- Domestic	18-90564	Guava Lane	Patricia Smallwood called the Sheriff's Office and stated that she was involved in a physical altercation with her fiancé, David Nelson, last night. When deputies arrived on scene, Patricia was intoxicated and refused to provide them with any information on what happened last night. Both parties refused to vacate the residence and separate for the evening and due to a lack of evidence and consistent statements, no arrest was made.		
Disturbance Domestic	18- 90537	I95 N in the area of MM278	V1 stated she was in an argument with her boyfriend, S1, while driving on I95. V1 stated that during the argument S1 elbowed her in the mouth and then threw her phone out the window when she tried to call 911. S1 then pulled over and left V1 on the side of the road and left to go back to Zephyrhills, FL. Contact was not made with S1 because his whereabouts is unknown. A charging affidavit for DV battery and tampering with a victim will be submitted to the SAO.
