 - (1) State v. Joseph Milano: 2010-136CFFA, Aggravated Assault, Honorable Kim C. Hammond (retired), Lead Counsel, Scott Westbrook (Assistant State Attorney), 06/17/2010. Reason: Client was in a federal witness protection program, he got into a fight with a customer over pizza, and his true identity was then discovered. This case followed and involved his wife's accusing him of aggravated assault with a firearm. The wife testified favorably for the defense. I chose not to cross examination the witness because I did not want to invite error. After the State rested its case, I successfully argued and the judge granted my JOA (judgment of acquittal). Even though the testimony was favorable, to successfully argue a JOA requires knowledge and understanding of the applicable case law. You must connect the law to the facts, distinguish cases that seem unfavorable and present your position clearly to the Court.
 - (2) State v. Giovanny Concepcion: 2005-575CFFA, Attempted Murder, Honorable Robert K. Rouse, Lead Counsel, Steve Nelson (Assistant State Attorney), 05/16/2005. Reason: My first jury trial. I learned about the purpose and significance of proper interpretation because client was not an English speaker.
 - (3) State v. Sean Todd Monti: 2016-00986CFFA, Aggravated Battery, Burglary of an Occupied Structure, Criminal Mischief and Resisting Officer Without Violence, Honorable Dennis Craig, Lead Counsel Regina Nunnally, Joseph Ledonne (Assistant State Attorney), 2017, the client was a prison release reoffender, the aggravated battery charge and the burglary charge required a maximum sentence which was 15 years day for day, no gain time. He was also facing habitual offender treatment which would require the 15 years to double to 30 years. He was facing a total of 60 years prison due to enhancements. I moved to sever the aggravated battery charge from the rest and tried two jury cases under the same case number. He was found guilty of a misdemeanor battery in the first severance. The second severance was more difficult because accademically the State could prove a burglary. However, the jury found him guilty of a trespass. Our trial strategy was to concede a trespass. The jury found him not guilty of the felony criminal mischief. Overall, he was found guilty of misdemanors and sentenced to county jail instead of prison.
 - (4) State v. George Wood: 2008-787CFFA, Trafficking Hydrocodone, Honorable Raul A. Zambrano, Lead Counsel, Edward Haenftling (Assistant State Attorney), 02/23/2011. Reason: This case was considered a bad case for the defense because it involved a video transaction. However, during the trial and after viewing the video, the detective continued to testify differently from the video. I argued to the jury that the video is the best evidence of what happened and that they should rely on that. After two hours of deliberation, the jury found him not guilty. Although the evidence and testimony may

vary in a trial, you must pay close attention to these details that develop in your case and be flexible to change your approach if these details are favorable.

- (5) State v. Jeffrey Nowden 2015-00046CFFA, Honorable David L. Walsh, Lead Counsel Regina Nunnally, Timothy Pribisco (Assistant State Attorney), Trafficking Heroine, Possession of Controlled Substance and Possession of Paraphernalia, 2016. Police received information that a group was smuggling drugs into the county from Chicago. My client was accused of smuggling heroine in his rectum. A traffic stop was conducted and all individuals were questioned. My client was arrested for possession of paraphernalia. However, the police allowed one of the occupants to leave although she retrieved cocaine from her vagina and gave it to the police. The same officer arrested my client for paraphernalia. My client was taken to the hospital for a cavity search. The lead detective claimed that my client retrieved the bag from behind and in it was heroine, pills and cocaine. The case went to trial and jury deliberated for almost five hours. My client was facing a 15 year mandatory minimum sentence. Instead the jury found him not guilty of the herion and guilty as charged for the rest. The judge sentenced my client to prison although he scored under 22 points. The case was appealed and remanded for resentencing. The successor judge, Matthew Foxman sentenced client to time served because he sat in prison illegally for six months.
- (6) State of Florida v. Michael Scott Wilson, 2017-01168CFFA Honorable Terence Perkins, Lead Counsel Regina Nunnally, Melissa Clark (Assistant State Attorney). Attempted First Degree Murder, Attempted Aggravated Battery and Grand Theft (Firearm). First case where insanity was a possible defense. Client was accused of setting up a booby trapf to kill his pregnant wife. Client suffered from mental health issues but was also using crystal methemphetamine. He was diagonsed paranoid schizophernic and was later evaluated by Dr. Louis Legum who opined he was insane at the time of the offense. Defendant was evaluated by the state's doctor, which opined that he was in fact insane at the time of the offense (placing an electrical device on the door) but was due primarily to Amphetamine abuse. I learned that unless insanity is a defense, no mental health evidence is allowed in the trial. The jury could not hear that he was suffering from paranoid delusions at the time of the offense. We essentially had no legal defense. So, I argued that the contraption set on the door was not for the wife. She was in Tennessee when he drove down from there to the house in Palm Coast to get his belongings. The jury was out 2 and half hours. Client was found guilty of lesser of aggravated battery, quilty of the grand theft and not quilty of attempted first degree murder.

While in high school, I was president of the Beta Club and chaplin of the Anchor Club, graudated with Honors.

While at Daytona Beach Community College, I was a member of the English Society and Pre-Law Society and worked part time as an assistant secretary for Adult Education and Southeast Museum of Photography and graudated with Honors.

While at the University of Florida, I became of member of Zeta Phi Beta Sorority, Minority Political Science Club, Interned for Honorable George Kirkpatrick, State Senator (deceased), was a volunteer for Vocal Eyes (a program set up to help students who are visually impaired), led residence hall bible study, member of the North Star Leadership Council, President of Thomas Hall Dormitory and a member of the Murphree Area Council.

When I graduated from college: (1) I became a legal aid volunteer at Central Florida Legal Services around 1995: Honorable Shirley Green, County Judge was the administrator at the time. (2) I was a volunteer intern for the Honorable Hubert L. Grimes, Circuit Judge1995. (3) I volunteered my services as a campaign assistant.

After graduating from college, I worked at Dillard's for two years while applying to law school. I decided to get second job to save money for law school although I hadn't received an acceptance letter from any schools. My second job was full time, working as a Intake Coordinator for Juvenile Services Program. The program was created to assist juvenile clients to transition back into the community after release from their detention program. My duties included: intake, chaperone, van driver and mentoring. The program closed in April of 1997 but I started law school a month later. I was able to pay for my first quarter of law school.

When I was in law school: (1) I was a legal aid fellow for Seminole County Legal Aid in Altamonte Springs. (2) I interned for two public interest firms (Liberty Counsel and American Liberties Institute). (3) I was a member of the Black Law Student Association, held the office of community service officer and coordinated our community service projects. (4) I was president of Moot Court Board and I simultaneously coordinated our intramural moot court/oral argument competition for two years. As an intramural coordinator, I invited the local legal community of judges and attorneys to participate as judges for oral argument competitions.(5) Class Senator/Student Bar Association and member of the community service committee (6) I worked with a youth group at my church in Orlando and (7) inaugural inductee into Delta Theta Phi Law Fraternity, International.

After law school, I became a youth minister supervising over forty (40) children in 2009. As a youth minister, my primary duites were to teach bible study, Sunday School, coordinate outreach activities and mentoring. I taught practical principles to help the youth apply biblical principles in their everyday life.

I am a Teen Court judge since 2008. I preside over teen court sessions. The goal is to encourage teen court participants to learn from their wrong choices and apply what they will learn to their lives.

In summation, my work experiences, community involvement and leadership have revolved around serving the public as a leader, employee or member of prestigious organizations. I am a motivator, a coordinator of community service events, and driven to know how to apply the law. I am well aware of the challenges youth and indigent persons face especially in the court system. As an attorney, I have been exposed to a variety of complex, unpopular and volatile issues. I've written articles that reflect my keen awareness of issues that affect the court system. These experiences have prepared me for the diversity of issues which county judges encounter. It has allowed me to meet, to represent, and to serve all kinds of people, from all walks of life and I have treated them all fairly. You must see all sides of the issue to be effective: to be patient, a good listener and to be comfortable with the public.

I have a black belt in Tae Kwon Do. I trained for five and half years and I won numerous certificates, awards, trophies and medals for my perfomance. My instructor chose me to teach his youth class for a month. I received my black belt but I wanted to give up when training became more difficult. My father told me to give back all of my trophies and belts earned. He said he didn't want anything to remind me of the fact that I quit. My father taught me to finish what I start. Although I've been faced with many challenges, (death of father and sibling, law school accreditation process, etc.) I was taught and choose to have a "stick-to-it" attitude.

As a trial practitioner for almost 12 years, I have courtroom experiences, trial experience. My "stick-to-it" approach has enabled me to represent and counsel people experiencing difficult situations. I am appointed to cases that are not popular. I cannot pick or choose my clients. I cannot discard cases with ease, I've learned to work through differences of opinion. I've learned that every case turns on its own merits: one case is not the same as the other. I've learned to resolve conflicts and complex issues. Sometimes the task is not easy because potential damages are so great and the consequences can be detrimental. Nevertheless, I see it through to the end.

As a judge, you cannot pick or choose your litigants. You cannot please everyone. You have to preside over various cases, decide difficult issues and be patient with demanding litigants. I am accustomed to the demands of the court room especially in the circuit setting. In order to uphold the integrity of the court system, you must remain humble and follow the law. These factors and insights are essential to discerning the appropriate approach, a skill which is needed in our judicial system, a skill I have.
