				I am the Grandparent of four students that attend Flagler County Public Schools (one in Old Kings Elementary, two in Matanzas High School, and one in Indian Trails Middle School). Although parts of two consecutive school years have been marred by COVID restrictions, it is critical for the mental well-being of our children that a third year does not contain pointless regulation pertaining to a virus that does not affect children in any significant manner.
				Earlier this month, the CDC recommended that school districts across the country mandate unvaccinated children to continue to wear masks and socially distance themselves from other children. Evidence proves that children are exponentially more likely to be killed from taking the vaccines or suffer from debilitating conditions like myocarditis than they are to suffer negative health effects from COVID.
