In response to your inquiry below, the pictures and video from the red-light cameras are fed electronically directly to our vendor ATS. Any apparent violations that meet criteria established by the City are then sent electronically to our designated Traffic Infraction Officers (City employees) who determine whether or not it is a red-light violation. Our officers then click on a reject or accept button. A notice of violation is sent to those that are accepted.
