RE: City Manager Position

I am interested in exploring the possibility of providing the services desired by the City Manager for the City of Brunnell, Florida and have attached a resume for consideration as a potential candidate.

As a brief background about my interest in local government, I began my career in this area between undergraduate and graduate school for a rural county in my home state of West Virginia with a population of just over 10,000 residents where I worked as the first administrator serving the three member County Commission. My father was a hospital administrator, my mother was a school teacher, grandfather was the elected County Assessor, uncle was Superintendent of Schools and a cousin the circuit court judge. I have indeed looked back on this short period of just over a year as one of the most rewarding of my professional and personal life and must say it would be nice to assist a small local government in Florida.

I would expect that providing innovative and sound financial management plans, systems, and practices to address the current economy will be among the priorities of this position to assist the City Commission. Finance is an area of my greatest interests and accomplishments with numerous creative solutions forged for a Virginia county government as COO / CFO during a difficult economy similar to today as population increased 60% from 50,000 to 80,000 residents. Notable successes which could prove helpful in serving the City of Brunnell include:

- Complete turn-around in financial position for the county government with \$165M budget improving overall financial position from weak to strong which enabled construction of multiple new public facilities including schools, a new regional library, government center and recreation facilities;
- County and School Board consensus on a novel annual funding formula for the county education system, representing 60% of the total budget - 15,000 students, 1,900 employees, 18 schools with financing for construction of numerous new schools and SOQ needs through new sources:
- Restoring solvency in a water & sewer utilities operation with development of a 20 Year Plan and new rate structure that supported regional cooperation with water sales to neighboring localities and the U. S. Marine Corps at Quantico with the County's first Geographical Information System;
- Implementing a regional approach to mass transit for 70% of the county workforce commuting over 40 miles to Washington Metropolitan Area with supporting revenue structure; and,
- Working with President of a neighboring city University on a public / private partnership project to secure land / infrastructure by proffers and State grants for county construction of the University's College of Graduate & Professional Studies that now serves over 800 students.

If my qualifications offer a good match with those believed most beneficial to assist the City Commission at this time I would be very much interested in exploring the possibility of providing the services desired.
