CLERK DIRECTING TASC TO CONDUCT EVALUATION

It having come to the attention of the Court that an evaluation of the substance abuse and/or mental health treatment needs of the defendant is necessary, it is therefore,

ORDERED and ADJUDGED as follows:


1. TASC shall complete a written evaluation of the defendant, which shall include the following information:
 - a. Treatment requirements, if any.
 - b. Recommended level of treatment (inpatient or outpatient).
 - c. Recommended treatment providers, along with frequency and type of treatment needed.
 - d. Anticipated length of wait for the recommended services to be available.
 - e. If in custody, whether defendant shall remain incarcerated until the recommended treatment is available, or whether there are alternative treatment resources available which would allow the defendant's release pending primary treatment availability.

2. In conducting said evaluation TASC shall consult the following (if checked):
 - (x) (a) Affidavits and Reports charging of any pending violations of probation and community control.
 - (x) (b) Complaint affidavits of any pending substantive charges.
 - (x) (c) Family members/cohabitants of the defendant, as to treatment history, including whether it was inpatient or outpatient, voluntary or involuntary, successful or unsuccessful.
 - (x) (d) Information from the Dept. of Corrections, Probation & Parole, as to criminal history, as well as treatment history, including whether it was inpatient or outpatient, voluntary or involuntary, successful or unsuccessful.

3. The Defense Attorney shall provide to TASC a copy of this order by FAX, hand delivery, or some other means. Upon request by TASC, the DEPARTMENT OF CORRECTIONS is authorized and directed to provide to TASC orally or in writing, the information specified in 2(d) above (if checked).
4. TASC shall provide the evaluation to the Court with copies to the State and Defense, within fifteen (15) business days from the date of this order, absent an extension being requested and granted.
