PROBABLE CAUSE

During the year 2012, when the victim was twelve years old, the defendant, who was the [redacted] at the time, were residing in Alachua County as a family with the victim's [redacted].
During an interview at the Child Protection Team (in Flagler County where the victim currently lives), the victim advised she walked into the bedroom belonging to [redacted]. The defendant shut the door behind him and pushed her onto the bed. He had her pinned down on her back, removed her pants, pulled her underwear to the side and put his penis inside her vagina. She was screaming and crying and asking him to let her go. His body was "stiff" and was going up and down.
At the time of the victim's disclosure, the defendant was incarcerated in Florida Department of Corrections on unrelated charges. The defendant was interviewed while in prison and denied the allegations.
The defendant has since been released from DOC, but is incarcerated in Flagler County jail on pending Lewd and Lascivious Molestation charges on the [redacted].
According to the FDLE website, the defendant is also a registered sex offender for a 2000 conviction for Lewd, Lascivious Child Under 16 (Conspiracy to Commit) and a 2005 conviction for Lewd or Lascivious Battery Victim 12-15 years old.
