Phil Lindley is an Inspector with the Florida Department of Law Enforcement (FDLE), Office of Investigations. In September of 2014, the Office of the State Attorney, 7th Judicial Circuit requested FDLE assistance in an investigation into matters associated with a recorded conversation at the Flagler County Canvassing Board meeting on August 25, 2014. Following initiation of the FDLE investigation, FDLE acting pursuant to a search warrant, obtained certain electronic data and devices from the Flagler County Supervisor of Elections Office. Forensic analysis of the data revealed numerous recordings of communications made of numerous persons on numerous dates. Inspector Lindley undertook investigative efforts to locate, fully identify, and interview those recorded. Based upon the sworn testimony of the various witnesses that they were recorded without the knowledge and without giving their consent, and based upon review of the electronic recordings recovered at the Flagler County Supervisor of Election's office Inspector Lindley has probable cause to believe:

COUNT I: KIMBERLE WEEKS, on or about April 7, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Virginia Smith, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)

COUNT II: IN THAT KIMBERLE WEEKS, on or about May 6, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Shannon Brown, contrary to Florida Statute 934.03(1)(a). (3 DEG FELONY)

COUNT III: IN THAT KIMBERLE WEEKS, on or about July 11, 2014, in the County of FLAGLER and State of Florida, did intentionally intercept, endeavor to intercept or procure any other person to intercept or endeavor to intercept any wire, oral, or electronic communication of Michael Coomans, contrary to Florida Statute 934.03(1)(a). 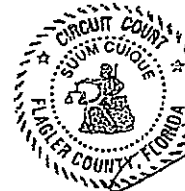

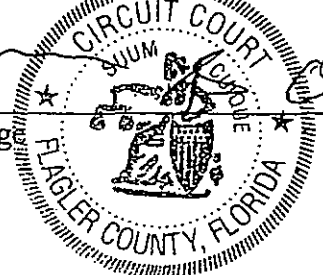
