**NARRATIVE CONTINUED**

Deputies located a 17 year old male, later identified as Elijah Rizvan, laying in the middle of the roadway with a gunshot wound to his upper chest, near his clavicle. At 0837 hours, Rizvan was pronounced deceased. A .380 shell casing was located near Rizvan's body.

Rizvan's girlfriend, [REDACTED] was present during the shooting and called 911. She advised that Rizvan had been shot in the chest and that he was bleeding heavily. During a brief initial interview with [REDACTED] she advised that she called Rizvan's friend BB [REDACTED] who called 911 and found out he had information on who may possibly be involved in the shooting. [REDACTED] advised that B had sent her a Snapchat picture with the screenname of someone he had put in touch with Rizvan shortly before the murder.

Detectives conducted an interview with [REDACTED] wherein she described a grey or silver passenger car pulling up to 7 Westford Lane and two black males exiting the vehicle and approaching Rizvan. [REDACTED] stated that the males grabbed Rizvan by the arms and one of them shot him in the chest area. The two males then entered the passenger car and sped off.

Detectives conducted an interview with [BB] and he advised that he was contacted on July 12, 2019 by someone on Snapchat who was interested in purchasing marijuana. He reached out to his friend Rizvan and asked if he could supply the drugs to the Snapchat contact. A price was agreed upon between the parties and BB gave the address of 7 Westford Lane to the Snapchat contact. He let Rizvan know that the Snapchat contact was on his way to purchase narcotics.

The Snapchat screenname was run through law enforcement databases and a matching name (witness 1) was located with an address listed as [REDACTED] Island Estates Parkway, Palm Coast, Florida, 32137. Deputies travelled to Island Estates Parkway and observed a silver Kia Forte (FL tag 7377XU) in the driveway along with a gray Ford Focus (FL tag LGSN18). A similar make vehicle was located on surveillance video passing 8 Westford Lane just two minutes before the murder.

On July 13, 2019 at approximately 0456, contact was made with three witnesses located at [REDACTED] Island Estates Parkway (witnesses 1, 2 & 3). Witness 3 is the registered owner of the Ford Focus (FL tag LGSN18). It should be noted a check of law enforcement databases revealed the Ford Focus was found to have hit on one of the ALPR cameras within Flagler County when it crossed I95 westbound on Palm Coast Parkway at approximately 7:09 pm, then back across I95 eastbound on Palm Coast Parkway at approximately 8:32 pm (Approximately 6 minutes after the shooting was reported).

**NARRATIVE CONTINUED**

Several audio and video recorded interviews have been conducted with these three witnesses and they each individually stated that on the evening of July 12<sup>th</sup> they traveled to 7 Westford Lane with the Defendant in the Ford Focus. Witnesses advised they were traveling there because the Defendant wanted to purchase marijuana. Interviews revealed that the Defendant exited the vehicle along with Witness 1. Witness 2 and 3 state that the Defendant approached Rizvan and shot him in the chest/neck area. Witness 1 stated that when he exited the vehicle with the Defendant he went to the trunk area of the car and he saw the Defendant grab Rizvan, demand narcotics, and then shoot him. After the shot, the Defendant and Witness 1 returned to the vehicle and it fled the scene. Witness 3 was driving the Ford Focus and he dropped the Defendant off at his apartment complex located 70 Riverview Bend South, Palm Coast, Florida, 32137. Witness 1, 2 & 3 returned to Island Estates Parkway where they remained until contacted by law enforcement on July 13, 2019.

The Defendant was subsequently located and transported to the Flagler County Courthouse for an interview. The Defendant's mother and step-father were present in the interview. The Defendant admitted traveling to the W section of Palm Coast on July 12, 2019 with the three witnesses previously mentioned. He denied being involved in a shooting and provided very little information about what happened that evening. The Defendant and his mother later indicated they no longer wished to provide information without an attorney and all questioning was stopped.


