Deputies travelled to Island Estates Parkway and observed a silver Kia Forte (FL tag 7377XU) in the driveway along with a gray Ford Focus (FL tag LGSN18). A similar make vehicle was located on surveillance video passing 8 Westford Lane just two minutes before the murder. On July 13, 2019 at approximately 0456, contact was made with three witnesses located at Island Estates Parkway (witnesses 1, 2 & 3). Witness 3 is the registered owner of the Ford Focus (FL tag LGSN18). It should be noted a check of law enforcement databases revealed the Ford Focus was found to have hit on one of									
the ALPR cameras within Flagler County when it crossed I95 westbound on Palm Coast Parkway at approximately 7:09 pm, then back across I95 eastbound on Palm Coast Parkway at approximately 8:32 pm (Approximately 6 minutes after the shooting was reported).
