## AMENDED INFORMATION

## CHARGE(S):

SEXUAL BATTERY BY PERSON 18 YEARS OR OLDER ON PERSON 12 OR OLDER BUT YOUNGER THAN 18 (SPECIFIED CIRCUMSTANCES)

- II) UNLAWFUL SEXUAL ACTIVITY WITH A MINOR (DIRECT)
- III) UNINFORMED HIV INFECTED SEXUAL INTERCOURSE (DIRECT)

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: VICTOR EUGENE WILLIAMS II on or between September 10, 2018, and September 11, 2018, in the County of FLAGLER and State of Florida, did commit sexual battery, as defined in 794.011(1)(h), upon E.R.D., a person 12 years of age or older but younger than 18 years of age, without E.R.D.'s consent, by inserting the penis of VICTOR WILLIAMS into the anus of E.R.D., and at the time of the offense special circumstances existed as defined by 794.011(4)(e), to wit: E.R.D. was physically incapacitated and/or physically helpless; and VICTOR EUGENE WILLIAMS II was 18 years of age or older at the time of the offense, contrary to Florida Statute 794.011(4)(a). (1 DEG FEL, PBL)

COUNT II: IN THAT VICTOR EUGENE WILLIAMS II on or between September 10, 2018, and September 11, 2018, in the County of FLAGLER and State of Florida, did, while 24 years of age or older, engage in oral, anal, or vaginal penetration by, or union with, the sexual organ of E.R.D., or VICTOR EUGENE WILLIAMS II did engage in the anal or vaginal penetration by any other object, of E.R.D., a person 16 or 17 years of age, to wit; VICTOR EUGENE WILLIAMS II did insert his penis into the anus of E.R.D., contrary to Florida Statute 794.05 (2 DEG FEL)

COUNT III: IN THAT VICTOR EUGENE WILLIAMS II on or between September 10, 2018, and September 11, 2018, in the County of FLAGLER and State of Florida, unlawfully did have sexual intercourse with E.R.D., another person, knowing that VICTOR EUGENE WILLIAMS II is infected with the human immunodeficiency virus infection, and having been informed that he may communicate this disease to another person through sexual intercourse without informing E.R.D. of the presence of the sexually transmissible disease and obtaining E.R.D.'s informed consent to the sexual intercourse, contrary to Florida Statute 384.24(2). (3 DEG FEL)
