

On Saturday, November 20, 2022 at 12:05am I, Deputy Cowan, was dispatched to Smiles Nite Club: 9 Palm Harbor Village Way, Suite A, Palm Coast, Florida 32137 in reference to a shooting. While enroute, dispatch gave information that a male in the bar had a gun that he shot a number of times. Once units were on scene, it was advised that there were no injuries and that the male, now known as Connor Anderson left on foot running north from the business. Units then advised they had a male matching the description in front of 28 Old Kings Road North, Palm Coast, Florida 32137. I responded to that location, once Connor was in custody, I responded to Smiles Nite Club.

Once at Smiles, Dep. Wallis and Deputy Perkins got everyone out of the business and established a crime scene. Witnesses began to explain that Connor was at the bar with his girlfriend, Jaime Botelho, having alcoholic drinks and got into an argument about the keys to his truck (white, 1997, Ford, F-150, bearing FL tag#CN3768) that was parked in front of the business. When Jaime told Connor that she did not have them, Connor got even more aggressively upset. Connor went outside to supposedly calm down. Jaime went to the bathroom with a female patron, Jennifer McCain, when Connor went outside. Witnesses stated that Connor then came back into the bar and immediately confronted Brittany Cartier (patron) with a gun in his hand by putting his arm around her neck from behind. Brittany stated that she thought she was going to die with the gun next to her face. Brittany stated that with that fear, she put her chin down so Connor could not choke her, dropped her weight to lower her body, to then be able to pull out from under his arm. When David Ghiloni, the bartender, saw this happening he immediately jumped over the bar to help Brittany. David stated that he grabbed Connor's arm to get him off of Brittany. David stated that Connor had the gun to David's head and he was in fear that he was going to be shot by Connor. David stated that the other male patrons in the bar (Paul Ibelli, Walter OConnor, Antonio Martins) also came to help and Connor was tackled to the ground. David stated that Connor shot off a couple of rounds while still being tackled, got up, and then shot off a number of rounds inside before leaving the business. Paul and Walter both stated that they saw Connor put the gun to David's head. Paul stated that Connor waved the gun at everyone while shooting and everyone was afraid that Connor was going to shoot them all. Rebecca Porter and Edward landoli were also in the bar and gave statements to the same information. Dep. Cuthbert was able to transport David to the location where Deputies were with Connor and David positively identified Connor as the shooter. It should be noted that Connor Anderson was in possession of the

firearm when he was located.

Det. Crosbee and Det. St John responded to the scene to take over the investigation. Glen Iannillo, the business owner, also arrived to give investigators access to the camera footage inside the business. The footage is consistent with the above information given by witnesses. All witnesses other than Connor and Jaime stayed on scene to speak with LEO. Once inside of the business, 6, 9mm, casings were found on the floor at various places towards the front of the bar. Photographs of the scene within the business, including casings and possible projectile paths, were taken by units on scene and uploaded to AEGIS. All units utilizing AXON body/fleet cameras were uploaded by the end of the shift. Supplements were completed by units involved. Dep. Bifano made contact with Jaime Botelho at her home of 5 Lake Success Place, Palm Coast, Florida 32137 to check on her welfare and to see if she could give any additional information. Please see Dep. Bifano's report for further information. When units took Connor into custody, he complained of back pain from falling. Connor was transported to Advent Health, where physicians cleared Connor of injury. I transported Connor to the Perry Hall Inmate Detention Facility without incident.

Connor was charged with the following:

- Shooting into or throwing deadly missiles into dwellings, public or private buildings, occupied or not occupied x6 (for each casing found at this time)
- Aggravated Assault x3 (Victims: Brittany Cartier, David Ghiloni, and Paul Ibelli)
- Battery (Victim: Brittany Cartier)
- Using firearm while under the influence of alcoholic beverages, chemical substances, or controlled substances
- Improper exhibition of dangerous weapons or firearms

There is no additional information available at this time.
