
- I) FELONY CRUELTY TO ANIMALS

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: JAMIER TAWAIN LEE BRIGHT, on or about April 2, 2022, in the County of FLAGLER and State of Florida, did intentionally commit an act to any animal which resulted in the cruel death, or excessive or repeated infliction of unnecessary pain or suffering, or caused the same to be done, contrary to Florida Statute 828.12(2)(a). (3 DEG FEL)

COUNT II: IN THAT JAMIER TAWAIN LEE BRIGHT, on or about April 2, 2022, in the County of FLAGLER and State of Florida, did alter, destroy, conceal or remove blood evidence, any record, document, or thing, with the purpose to impair its verity or availability in a proceeding or investigation knowing that a criminal trial, proceeding or investigation by a duly constituted law enforcement agency of this State was pending or was about to be instituted, contrary to Florida Statute 918.13. (3 DEG FEL)
