reference to a "Disturbance Domestic" which occurred at 408 S. Pine St. Upon my arrival I made contact with Yolanda Williams who stated her husband, Jermaine Williams, struck her multiple times. Yolanda stated earlier in the day, approximately 1930 hours, Jermaine became upset at her for spending \$80.00 to get her fingernails done. Yolanda stated Jermaine forced her to cut the fake nails off by threatening to smash them off with a hammer if she did not cut them. Yolanda stated she was in fear that Jermaine would carry out the threat of smashing her fingernails off with a hammer, so she did cut them off. Yolanda stated that after she cut the fake fingernails off Jermaine left the residence.

Yolanda stated Jermaine returned to the residence at approximately 2350 hours at which time he began arguing with her because he believed she was having an affair. Yolanda stated her youngest son sang at a funeral earlier in the day and Jermaine believed she was having an affair with the deceased's child's father. Yolanda stated Jermaine began "beating" her for "about 30 minutes" in their bedroom. Yolanda stated Jermaine punched her with a closed fist in the head, body, face, and stomach "over and over." Yolanda stated Jermaine also drug her around by her hair, ripping some of it out.

Yolanda stated Jermaine then woke up their youngest child [REDACTED] and forced him to watch Jermaine beating her. Yolanda stated while Jermaine was forcing [REDACTED] to watch, Jermaine stated "your mom is a whore, and this is what whores get when they sneak around." Yolanda stated Jermaine then took [REDACTED] cellphone and continued "beating" her for another 20 minutes. Yolanda stated Jermaine then woke two of the other children, [REDACTED] and [REDACTED] and took their cell phones so they could not call for help.

Yolanda stated Jermaine continued to "beat and berate" her for another 30 minutes until she then made her way to the garage where Jermaine continued to "attack" her. Yolanda stated she retreated to the garage because the garage door wouldn't secure properly so she would be able to get out even if it was locked. Yolanda stated she couldn't exit through the front door and front porch because she observed Jermaine lock the front porch door in an attempt to slow her down if she did try to escape out the front of the residence. Yolanda stated Jermaine continued punching and kicking her until he picked up a wooden sign which said [REDACTED] and struck her in the side with it. Yolanda stated she then ran out the side door and ran to Jermaine's parent's house at 501 S. Cherry St. where she called law enforcement from. Yolanda stated while running to 501 S. Cherry St. Jermaine was behind her stating "don't make me chase you." Yolanda stated once at 501 S. Cherry St. Jermaine was unable to open the front door due to it being locked but stated to his father to not make him come back.

Yolanda stated Jermaine has been beating her for over 30 years, but she has been afraid to report the violence because she was in fear that he would kill her. Yolanda stated Jermaine has threatened to kill her in the past.

I observed bruising and swelling on both sides of Yolanda's head. I observed bruising on Yolanda's wrists. I observed multiple locks of hair missing from Yolanda's head. All injuries were consistent with Yolanda's statement. Yolanda refused medical treatment but stated her head, wrists, and ribs were sore.

Yolanda completed a sworn written statement, was issued a domestic violence rights and remedies packet, and signed a Marsy's law form. Multiple digital photographs were taken of Yolanda's injuries. All paperwork and photographs will be submitted into records/evidence at the Bunnell Police Department.

I then responded to 408 S. Pine St. where I observed Jermaine standing in the front yard next to his black Chevrolet truck. I then made contact with Jermaine and asked him what had happened between himself and Yolanda. Jermaine responded that he was trying to call Yolanda and did not acknowledge that a disturbance occurred. I then secured Jermaine in handcuffs and placed him in the back seat of my patrol car. I then advised Jermaine that he was being placed under arrest for domestic violence.

Officer Sanders then returned to 501 S. Cherry St. and provided Yolanda a ride back to 408 S. Pine St. Officer Sanders then made contact with the three children inside the residence and took photographs of the damaged wooden sign and clumps of hair on the floor. See Officer Sanders' supplement report for further.

I then transported Jermaine to the Flagler County Inmate Facility where he was turned over to jail staff without incident. The Florida Department of Children and Families will be contacted regarding the disturbance.
