Upon my arrival on scene, I observed multiple objects in the roadway that appeared to be purposely placed such as two chairs, a blanket, candles and other miscellaneous objects. While on scene, a younger male exited the residence, held a hat up, turned around and returned back inside. A few moments later, another male with brown hair in a pony tail, wearing overalls exited the residence and became combative with law enforcement. The male, later identified as Robert Detherow (DOB 06/25/1968) continued yelling at law enforcement in regards to arresting Sheriff Rick Staly, today is Judgement day, you have no authority over here and continuing to shout Sheriff Rick Staly being arrested. While he was shouting over me, I asked Robert multiple times if the items in the roadway was his stuff, which he then advised "do you want to see my dick, shoot me bitch, you fuck me off, fucking cunt" and removed his penis from his clothing while moving his hand in a manner as to stroke his penis. I continued to ask if the items in the roadway was his stuff as he continued shouting over deputies. A neighbor who was riding his bike and walking his dog then attempted to intervene and stated "Robert" and motioned him to walk towards the roadway towards him on the east side of the residence, opposite of deputies. I advised Robert I was just attempting to remove the objects from the roadway to clear the roadway and avoid throwing his items out. Robert then walked towards the public roadway towards the male. It is unknown if Robert still had his penis exposed at this time. Robert stated to the male he was going to heaven and to go home to heaven prior to hugging him, giving him a kiss on the cheek and then returning to his residence and asked if I read what the white board stated, and then stated I was going to prison.

While attempting to explain to Robert I did not want to throw his items out, he advised "you are a nigger" while pointing at me and then stated "you are a black man and so am I" while pointing at Deputy Tassey. I continued to reiterate I did not want to throw the items away on the roadway if they belong to him, however, Robert continued to be combative. Robert then grabbed a full glass bottle of wine, threw it up in the air the opposite direction of deputies, which then landed in his driveway.

I then began to put my gloves on to remove the items from the roadway. I entered into the middle of the roadway to begin moving the items out of the way. As I grabbed a sign off the road way and another object, Robert was observed grabbing a round glass bottle full of an unknown liquid with both hands while standing near the doorway of his residence. Robert then began charging forward towards me and threw the bottle directly towards me while attempting to remove the items from the roadway. The bottle landed right before the roadway near the swale of his yard. Out of fear of being struck by the item or another object thrown by Robert, and being injured by the bottle or any other objects thrown at me, I dropped the items and ran towards

cover and drew my firearm. Robert then returned into his residence.

Myself and Deputy Tassej took cover behind my patrol car that I then repositioned to utilize until additional units arrived on scene. Once additional deputies arrived on scene, Robert continuously entered and exited the residence, continuing to be uncompliant while shouting at deputies. Due to the music being played by Robert, Deputies were unable to hear what he was stating.

Robert then walked the speaker playing the music to the roadway and placed it with the other items. While attempting to have Robert speak with deputies, he then charged towards the middle of his yard where a dry erase white board was placed, grabbed the board, charged towards deputies who ordered him to put the board down. Robert continued charging towards deputies and then through the board down as he was hit with a less lethal impact weapon to gain compliance, however, was unsuccessful. Robert then returned to his residence and continued to walk in and out as additional deputies arrived on scene.

Deputies attempted multiple times to speak with Robert but were unable to gain contact with him via phone call and through PA systems.

At this time, Robert intentionally and unlawfully threatened by act to do violence to deputies. By throwing the glass bottle full of an unknown liquid with both hands at me, it created a well-founded fear that I would have been seriously injured had Robert been closer to me, was able to throw the bottle further at me if it was not full of the liquid and lighter, and if I did not move to take cover. Additionally, it appeared Robert had the ability to carry out the threat of harming deputies by charging at them with the white board and throwing it towards them. This act created a well-founded fear that deputies would had been harmed if he would have continued and was not struck with the less-lethal in attempts to prevent him from continuing to charge at deputies.
