NARRATIVE	The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the <u>4th</u> day of <u>December</u> , <u>2025</u> , at approximately <u>07:44</u> hours at <u>1400 Blk N US HWY 1</u> , violated the law and did then and there:

	4. The Defendant did willfully flee or attempt to elude a law enforcement officer in an authorized law									
	5. enforcement patrol vehicle with agency insignia and other jurisdictional markings prominently displayed,									
	6. with siren and emergency lights activated, contrary to F.S.S. 316.1935(2).									
	7.

9. On 12/04/2025, at approximately 0744 hours, Sgt. Braun, was traveling southbound on N. US Hwy 1 within										
10. the City of Ormond Beach, Volusia County. The posted speed limit in this area is 55 mph. I observed										
11. a gray Ford Taurus traveling northbound in the outside lane. Sgt. Braun visually estimated the vehicle's										
12. speed to be approximately 85 mph. Sgt. Braun activated the front antenna of his Stalker DSR 2x radar,										
13. which produced a clear audio doppler tone and a reading of 88 mph.

16. Sgt. Braun conducted a U-turn and accelerated to conduct a traffic stop. Sgt. Braun closed the distance										
17. behind the vehicle at the intersection of N. US Hwy 1/Airport Rd., where the vehicle had slowed for										
18. traffic. Sgt. Braun was close enough that he could see the reflection of his patrol vehicle in the										
19. rear bumper. Sgt. Braun activated the emergency lights and siren on his marked Ormond Beach Police										
20. Department Dodge Durango, which displays agency insignia and other jurisdictional markings. Sgt. Braun										
21. provided the Florida license plate number RWZD58 to dispatch. The vehicle continued northbound in the										
22. inside lane, failing to yield. Sgt. Braun noted that other motorists were yielding to his emergency										
23. lights and siren.

26. Sgt. Braun continued behind the vehicle with his emergency equipment activated. The vehicle continued										
27. northbound to approximately Wall Ave., then merged into the outside lane and accelerated around traffic.										
28. It was apparent the vehicle was actively attempting to flee. Sgt. Braun deactivated his emergency lights										
29. and siren, as he did not intend to pursue. Sgt. Braun advised dispatch of the vehicle's direction of										
30. travel and lane position.

33. Sgt. Braun was aware of other Ormond Beach Police Department officers in the area and advised the										
34. potential deployment of Stop Sticks. The vehicle passed Ofc. Lyster's position at Ormond Lakes Blvd./N.										
35. US Hwy 1, at which time Ofc. Lyster advised the vehicle's approximate speed was 90 mph.

38. Sgt. DeLong was positioned at Pine Tree Dr./N. US Hwy 1 with Stop Sticks deployed. The vehicle drove  
39. around the deployed Stop Sticks and stopped in the turn lane approximately 350 feet north of the deployment  
40. location.

43. Sgt. Braun, along with Volusia County Sheriff's Office deputies, conducted a felony stop on the  
44. vehicle. The driver complied with verbal commands and exited the vehicle. Sgt. Braun observed a pistol  
45. magazine and handcuffs on the left side of his belt, and a holstered pistol on the right side of his  
46. belt.

49. The driver continued to comply and was secured in handcuffs behind his back. Sgt. Braun removed  
50. the pistol and observed a Flagler County Sheriff's Office badge affixed to his belt. The driver asked,  
51. "What is going on," to which Sgt. Braun advised him he was under arrest for fleeing and eluding. The  
52. driver laughed and stated, "When did that happen." The driver was turned over to Ofc. Lyster to be  
53. searched and secured in his patrol vehicle.

56. The driver was positively identified as Defendant Ardit Coma via his Flagler County Sheriff's Office  
57. identification card and later by his Florida driver's license.

60. While the Defendant was secured in the rear of Ofc. Lippack's patrol vehicle, Sgt. Braun read him  
61. his Miranda Warnings from a card issued by the State Attorney's Office. The Defendant stated he understood  
62. his rights and waived them.

65. Sgt. Braun advised the Defendant of the reason for the stop and explained that he failed to yield  
66. to his emergency lights and siren while other motorists did. The Defendant stated he was unaware Sgt.  
67. Braun was behind him with lights and siren activated. He further stated he was en route to work at  
68. the Flagler County Sheriff's Office and that Ormond Beach Police Department had stopped him in the  
69. past.

72. It should be noted the Defendant did not activate any emergency lighting on his unmarked vehicle.  
73. The vehicle was dry and the windows unobstructed. The distance from the point Sgt. Braun closed in  
74. behind the vehicle to where it stopped was approximately 1.9 miles.

77. Contact was made with Flagler County Sheriff's Office command staff, who responded to the scene  
78. and took possession of the vehicle and the Defendant's work property.

81. The Defendant was transported to OBPD for paperwork, then to VCBJ without incident.

84. A copy of the radio transmission was submitted to Evidence.com.
