As I entered the residence, I observed a white female personally known to me as Amber Bruder, exiting the back bedroom. As Amber exited the back bedroom, I advised her the reason why we were at the location, and then asked why her son was outside unsupervised. When I asked this question, Amber refused to answer but continued to walk towards me. When Amber got close to me, she forcefully pushed me with one hand, and yelled "Get out" as she attempted to close the door with the other hand. After Amber pushed me, she was subsequently secured in handcuffs.  After Amber was secured in handcuffs, Officer Baker and I conducted a cursory of the residence for any other children/occupants. During the cursory search Officer Baker located an infant, later identified as Kaya Bruder (DOB 06-02-19) laying face down on the bed, with a pillow partially covering her head. When Officer Baker noticed Kaya laying in the bed facedown, with a pillow partially covering her head, she immediately checked on her well-being by picking her up. When Officer Baker picked Kaya up it was discovered that she was only sleeping and the diaper she was wearing was completely soiled in body waste.  After completing the cursory search, I walked Amber and Kayden out to my patrol vehicle. While walking out to my patrol vehicle, I noticed Kayden was not wearing shoes, so I picked him up to prevent him from burning his feet. When I bent over to pick Kayden up it caused my AXON BWC to temporarily turn off. While at the rear of my patrol vehicle I read Amber her Miranda rights from a department issued Miranda Card. Post Miranda Amber refused to speak with me and refused to provide me with Kayden and Kaya's complete personal information.								
While Officer Baker and I completed our investigation, I placed Amber, Kayden, and Kaya in the air condition within the prisoner compartment of my patrol vehicle. While Amber, Kayden, and Kaya were in the prisoner compartment of my patrol vehicle I took several digital photos to show the condition inside of the residence. While taking photos I noticed trash throughout the residence, with empty beer and liquor bottles within the bedroom that Amber exited. After taking several photos, I contacted The Department of Children and Families, and spoke to Lyn ID # 362. When I spoke to Lyn, she advised an investigator would be responding to the incident.  Based off the statements provided by both witnesses and the fact that Kayden was discovered roaming a busy parking lot, completely naked without supervision for approximately 30 minutes, I placed Amber under arrest for child neglect and battery on a law enforcement officer.
