informed me that a student might have a gun on campus. Dean Millette received a call from Ms. Kelley (teacher) stating there may be a student with a handgun on campus.

Ms. Kelley noticed several students in her class seemed to be upset. Ms. Kelley asked the girls what was wrong. Several of the girls informed Ms. Kelley that suspect Dewuan Brinson had a gun on campus but the gun did not have a magazine. Ms. Kelley immediately contacted Dean Millette. Dean Millette and I went to building 9 on the second floor to remove the student from class. The student was escorted to the Dean's office. Dean Millette asked Dewuan if he had anything on his person or in his book bag that he should not have on campus. Dewuan stated [REDACTED], [REDACTED]. Dean Millette opened the book bag and was able to see a weapon. The bag was immediately turned over to me.

I opened the bag and noticed the handle of a tan in color gun with the magazine well empty. I retrieved the gun from the bag to make the weapon safe. I was able to cycle the slide of the gun, which ejecting a .45 caliber round out of the chamber. The gun is a Smith and Wesson M&P.45 caliber handgun with serial number HST5697. It should be noted that this firearm can be fired with a round in the chamber and no magazines in the chamber (stamped on side of the gun. The gun was run through NCIC\VCIN to determine if the gun was stolen. The gun was placed in a gun safe in my office for temporary safekeeping during the investigation.

Dewuan's parents were notified of the incident and responded to the school. Detective Erlandson interviewed Dewuan. Dewuan stated that [REDACTED]
