Elizabeth stated that she has not actually had voice contact with Charles since sometime in January. On February 20, 2017, Elizabeth contacted Dorothy via Facebook messenger to obtain phone numbers for Charles and Dorothy as she had a new phone and lost contact information. Dorothy told Elizabeth that Charles was in Georgia for two (2) weeks. Elizabeth was told that Charles does not have his phone but would pick it up when he returned. Dorothy told Elizabeth that she talks to him once a day from someone else's phone. On February 28, 2017 Elizabeth received a message, from who she assumed to be Charles, stating his phone was dead but would be home in three (3) hours and he would call her then. It should be noted that this time frame was inconsistent from when Dorothy stated Charles would be returning home. Elizabeth never received a call from Charles. Elizabeth ran into a mutual friend of hers and Charles, John Bair, at Daytona Bike Week. Through conversation it was discovered that John was under the impression that Charles was living with Elizabeth and working with Elizabeth's husband. John had heard from coworkers that Charles was residing with Elizabeth. Elizabeth sent Dorothy and Charles a gender reveal party invitation that was on March 18, 2017. Elizabeth stated that she had not received an RSVP from Dorothy or Charles so on March 15, 2017; she had her mother (Rose Carver) contact Dorothy to find out if they were going to be able to attend the party. Elizabeth received a message from Dorothy on the same day stating that she (Dorothy) had just got off the phone with Charles and they planned on attending the party. On March 18, 2017, the day of the party, Elizabeth received a message from who she assumed to be Charles, stating that something had just come up and they would not be able to attend. At the end of the message it stated that he (Charles) would explain later.
