<b>NARRATIVE</b>		The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the _____ day of February, 2017, at approximately _____ <input checked="" type="checkbox"/> a.m. <input type="checkbox"/> p.m. at 80 Pine Tree Lane Bunnell Florida within FLAGLER County, violated the law and did then and there: Dorothy Singer, on or between February 8, 2017 and April 7, 2017, in the County of Flagler and the State of Florida, did unlawfully kill and murder Charles Singer, a human being, by shooting him with a firearm, and did perpetuate said killing from a premeditated design to effect the death of CHARLES SINGER, and while in commission of said offense did actually possess and use a firearm, and did discharge a firearm, causing death or great bodily harm. The facts to support this charge are as follows:  On March 23, 2017 the Flagler County Sheriff's Office received a report from Elizabeth Ellis who was concerned about her brother, Charles Singer's, whereabouts. Deputies made contact with Dorothy Singer, Charles' wife, at their residence (80 Pine Tree Lane, Bunnell Florida, 32110) who stated to Deputies that she kicked Charles out approximately two (2) months prior. At that time, Charles was entered into NCIC/FCIC as a missing adult. A location request was conducted for Charles' cell phone. The location request received stated Charles' cell phone was utilizing the tower at County Road 304 and State Road 11 in Bunnell, Florida. This is the cell tower that is utilized when at Charles and Dorothy's residence.

On March 29, 2017 contact was made with Elizabeth via telephone. Elizabeth provided a statement as to why she was concerned about Charles. Elizabeth stated that she has not actually had voice contact with Charles since sometime in January. On February 20, 2017, Elizabeth contacted Dorothy via Facebook messenger to obtain phone numbers for Charles and Dorothy as she had a new phone and lost contact information. Dorothy told Elizabeth that Charles was in Georgia for two (2) weeks. Elizabeth was told that Charles does not have his phone but would pick it up when he returned. Dorothy told Elizabeth that she talks to him once a day from someone else's phone.

On February 28, 2017 Elizabeth received a message, from who she assumed to be Charles, stating his phone was dead but would be home in three (3) hours and he would call her then. It should be noted that this time frame was inconsistent from when Dorothy stated Charles would be returning home. Elizabeth never received a call from Charles. Elizabeth ran into a mutual friend of hers and Charles, John Bair, at Daytona Bike Week. Through conversation it was discovered that John was under the impression that Charles was living with Elizabeth and working with Elizabeth's husband. John had heard from coworkers that Charles was residing with Elizabeth.

Elizabeth sent Dorothy and Charles a gender reveal party invitation that was on March 18, 2017. Elizabeth stated that she had not received an RSVP from Dorothy or Charles so on March 15, 2017; she had her mother (Rose Carver) contact Dorothy to find out if they were going to be able to attend the party. Elizabeth received a message from Dorothy on the same day stating that she (Dorothy) had just got off the phone with Charles and they planned on attending the party. On March 18, 2017, the day of the party, Elizabeth received a message from who she assumed to be Charles, stating that something had just come up and they would not be able to attend. At the end of the message it stated that he (Charles) would explain later. Rose contacted Dorothy after having not received a phone call from her or Charles, to get an explanation of their absence. Dorothy told Elizabeth the FBI showed up at her mother's residence (Doris Harmon) conducting a narcotics investigation on Charles.

Elizabeth advised that she was told Dorothy contacted Charles' place of employment and stated that Charles had put his hands on her for the last time and he had the choice to move in with his sister or go to jail. Dorothy told his employer that he chose to move to his sister's house and would not be returning to work.

After the missing person report was filed both Elizabeth and Rose received a text messages from Charles' cell phone stating he made a mistake and he is working in Kentucky while he figures this situation out. There was a picture attached to the message that appeared to be taken at his place of employment. Elizabeth noticed mistakes in the messages that were odd as Charles is legally blind and only utilizes the talk to text function. The mistakes made would not be made with utilizing that function, according to Elizabeth.

Multiple contacts were made with Dorothy at her residence to obtain information in reference to the missing person case. Through those contacts Dorothy stated that Charles left on February 10, 2017. When Charles left he took his belongings to include his cell phone and all credit/debit cards. Dorothy stated she has a joint bank account at Vystar with Charles however he took her card linked to the account when he left.

Vystar provided records for the bank account. There were transactions at the following locations:



- February 9, 2017- 1208 South State Street Bunnell Florida Dollar General (\$37.72)
- February 13, 2017 – 1208 South State Street Bunnell Florida Dollar General (\$40.23)
- February 10, 2017 – 600 North State Street Bunnell Florida Ace Hardware (\$36.35)
- February 17, 2017 – 872 North Nova Road Daytona Beach Florida City Thrift (\$20.14)
- February 25, 2017 – 174 South US HWY 17 Palatka Florida Vystar ATM (\$400.00)
- March 7, 2017- 1024 South State Road 19 Palatka Florida Walmart (\$53.44)

Video surveillance was obtained from the Vystar ATM transaction as well as the Walmart transaction. The surveillance footage showed Dorothy utilizing the account for the transactions. It was determined to be Charles' credit/debit card to make the ATM withdraw. The records indicate that Dorothy's credit/debit card was used for the other transactions. A receipt was obtained from the two (2) Dollar General transactions that showed that 409 Carpet Cleaner and Clorox Bleach was purchased. A receipt was provided from Ace Hardware that showed a camouflage tarp, moth balls, and moth crystals were purchased. The receipt was signed "D. Singer." Dorothy stated to Detective Moy in an interview on April 7, 2017 that she purchased the tarp and moth balls.

Charles had an EBT card account. Records were received that showed the account was utilized on February 27, 2017 at Dollar General. Video Surveillance was also obtained from this transaction that showed Dorothy utilizing the account. While at Dorothy's residence on April 3, 2017, Dorothy consented to a walk of her property. Detective Conrad located a suspicious area in the rear of Dorothy's residence. There was a john boat flipped upside down with wood pallets, branches and debris unnaturally piled on top. There was a camouflage tarp visible in the pile. It was later determined that this camouflage tarp is consistent with the camouflage tarp purchased at Ace Hardware on February 10, 2017.

Cellular telephone records were received for Dorothy and Charles' cellular telephones. The records included location data of each time the telephones accessed a tower. Analysis was completed for both phones which revealed Charles' phone never left the Flagler, Putnam or Volusia County area since he was last seen. The analysis also revealed each time Charles' telephone was utilized; it was immediately adjacent to Dorothy's telephone. Based on this analysis, it appears Dorothy was in possession of Charles' telephone and continued to use the telephone to create the illusion he was alive and well.

A search warrant was obtained for the residence and property. The search warrant was executed on April 7, 2017 and human remains were subsequently located under the john boat in the back yard of the residence. Under the john boat, near the body, was a bag of moth balls and a camouflage tarp. During the search warrant, FDLE located suspected blood on the headboard, carpet and curtains in the master bedroom. This evidence was not visible to the naked eye and was only detected after forensic processing. Crime scene analysts with FDLE located a box for moth balls under a sink and packaging for the camouflage tarp that was purchased by Dorothy. Analysts also located the wallet of Charles Singer, including his driver's license, but the wallet did not contain Charles' EBT card or the Vystar cards.

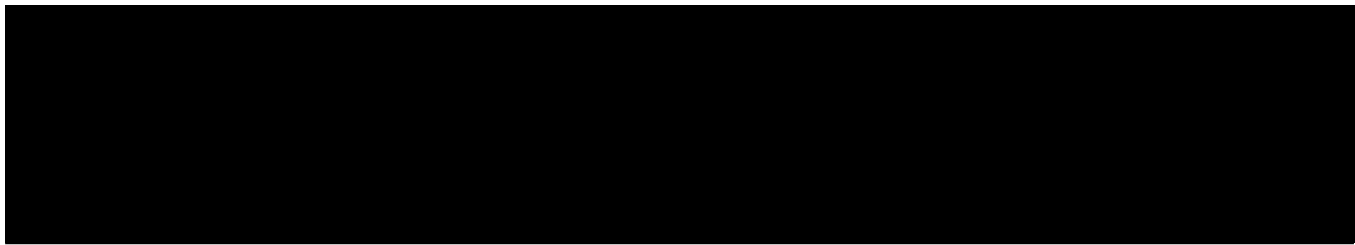
An autopsy was conducted on April 10, 2017. The human remains were identified as Charles Singer by part of a tattoo visible on the body. The cause of death was determined to be by gunshot wound. There were five (5) gunshot wounds located on Charles' body; four gunshot wounds to his head and one on the chest area. Three of the gunshots to the head were located on the top of the skull and one to the right temple. Charles was found wrapped in a camouflage tarp and on top of a comforter and pillow. The comforter that Charles was wrapped in appeared to match other bedding located in the residence. The manner of death was determined to be a homicide.

Interviews were conducted at Charles' place of employment, Flagler County Roofing, on April 12, 2017. Donna Miller stated that Charles did not show up for work on February 8, 2017. Donna received a call from Dorothy on February 9th, 2017. Dorothy told Donna that Charles' put his hands on her again. Dorothy told Donna that he was given an ultimatum to go to jail or move to his sister's house. Dorothy stated that he chose to go to his sister's house. Donna Miller confirmed Charles has not shown up for work since before February 8, 2017.

Dorothy's place of employment, AO Precision Manufacturing, was contacted on April 5, 2017. It was determined that Dorothy did not show up to work on February 9th 2017 and did not call to excuse her absence. Dorothy contacted her employer on February 10th, 2017 and sated she would not be into work for that scheduled shift.

A firearm was turned over to the Flagler County Sheriff's Office from Tracie Harmon, who is Dorothy's sister. The firearm was a five (5) shot .22 handgun North American Arms. Tracie advised that Dorothy had the firearm in her possession for approximately one (1) year and returned it over to Tracie approximately 2 months ago. This is consistent with the time frame in which Charles was last seen.

This firearm was sent to FDLE for an analysis to determine if this was the firearm used to in the murder of Charles. An expert with FDLE has indicated this firearm cannot be excluded as the possible murder weapon. The FDLE report issued on April 14, 2017 states that a bullet and bullet fragment collected at autopsy were identified as .22 caliber class and having been fired from the same firearm.
