unit. Susan stated she is currently going through a divorce with Mark and has been having issues with his behavior and alcohol consumption.

Susan went on to describe the incident with Mark to Deputy Wallis and subsequently completed a Sworn Written Statement. The content of the statement is written below:



"Today working in office - Mark asked if I wanted a sandwich I said no he then said what pictures are you hiding. I said no pictures I'm working. He said I can put a bullet in your head. He grab my keyboard and broke it broke the Internet and grab my phone. I went to the master bedroom to get my phone and he threw the phone at my leg. Then I ran to the door and he grab me trying to prevent me from leaving but I got out."

I, Detective Corporal Agustin Rodriguez, was then notified about the situation by FCSO Supervisors on-scene. Your Affiant was then requested to apply for an arrest warrant and a search warrant for the residence.

I learned that Susan's verbal statement to Deputy Wallis contained more details about a more violent incident that occurred last night (5/25/2022) at approximately 8:00 PM. I then contacted Deputy Wallis via telephone and asked if I could speak to Susan directly to obtain her verbal statement.

Susan advised that last night, at approximately 8:00 PM, she and Mark were in a verbal argument. She advised that Mark made statements about killing himself and her. She elaborated and stated that she was in her own private bedroom alone, when Mark entered, holding a silver/gray pistol. Susan advised she saw the pistol in Mark's hand, but that he moved the pistol behind his back, out of her view. Susan stated that Mark then stated to her "I could kill you right now" and "I'm going to put a bullet in your head." Susan went on to state that Mark then left her bedroom and went to the master bedroom, which is his primary sleeping area. Susan advised that she then heard a gunshot. Susan stated that she then ran to the bedroom to see what happened and saw Mark standing near the bed. She advised that Mark then stated "Now I know how this works, and you're next."

Susan went on to describe the other events that occurred on this date (5/26/2022). She stated that Mark got upset with her again this morning and began destroying her work station in the house. She advised that Mark then took her cellular phone and retreated to his bedroom once again. She stated that she asked for her phone back, at which time Mark threw the phone, ultimately striking her in the leg, causing a slight red mark. Susan advised that once she had her phone in her possession, she attempted to leave the residence. She advised that she made it to the front door and opened it with the expectation of exiting the residence and calling 911. Susan advised that Mark then followed after her and "grabbed and pulled" her by her arms and shirt in an effort to

prevent her from leaving. Susan stated that she then began screaming "Help! Help!" with the hopes that one of her neighbors would hear her pleas. Susan advised that she was eventually able to escape from Mark's grasp, at which time she ran down the street to a neighbor's home, where she was able to finally call 911.

Susan was asked to raise her right hand in front of Deputy Wallis and swear to her statement, which she did.

Upon searching CCIS (Benchmark) for Mark's criminal history, it was discovered that Mark was found guilty of Battery on May 7th, 2010, in Volusia County (Ref. Case # 2010 037699 MMAES), thus making this offense of Domestic Battery a Felony of the third degree.

It should also be noted, a non-expiring domestic violence injunction was located that was served on 05/19/2010 in Volusia County with Mark being the respondent. Per the injunction, Mark cannot possess any firearms or ammunition and to surrender all firearms/ammo to VCISO.

Per Susan, Mark's parents had given him a couple handguns and a long gun to sell, which he had yet to do so.

Due to the above circumstances, on-going resources were deployed in attempts to make contact with Mark due to the above incident, but Mark has been uncooperative and will not comply with lawful orders from Deputies on scene.

Presently, the Flagler County Sheriff's Office's SWAT team is standing by in the driveway of the residence.
