### Pilot Program for Backyard Chickens

#### Proposed regulations for pilot program:

- Two (2) year program
- Permit fee \$50.00 as set by Resolution
- Coop and run set up prior to allowance of chickens on property
- Permit allows Animal Control Officer access to chickens for inspections
- Limited to twenty-five (25) permits issued city-wide



### Pilot Program for Backyard Chickens cont.

- Limited to four (4) hens allowed per homesteaded Single-Family Residential (SFR) parcels
- Letter informing neighbors of participation in chicken pilot program
- Requires two (2) class certifications: Care/Raising of Chickens & Manure Management
- Requires a fly retardant bin for manure
- Submit a site plan with the proposed setbacks



## Pilot Program for Backyard Chickens cont.

- Size and setback specifications
  - Not to exceed 100 sq. ft. per SFR lot
  - Coop shall be located behind the front and side street building facades of the principal structure
  - Set back at least ten (10) ft. from rear property line and shall meet the interior set back requirements of the zoning district
  - In no event shall coop or any part thereof, be permitted within an easement
  - Maximum coop height eight feet (8')



## Pilot Program for Backyard Chickens cont.

- Additional regulations: no slaughtering, no fighting, no selling of chicken/eggs or fertilizer, and eggs are for personal consumption
- At pilot program sunset date, option for good standing residents with existing permit and backyard chickens to retain permit as a non-conforming use on property until attrition
- Non-conforming use permit remains at existing propertynot transferable until attrition
