| To wit: Cornelius Baker and Patricia Rossa committed the offense of Armed Home Invasion Robbery, Armed Kidnapping and Aggravated Battery at the location of 339 Michigan Avenue, Daytona Beach, Florida on the aforementioned date at approximately 10:30am (Daytona Beach Police Department Case# 2007-000566). The victim has been identified as Elizabeth Uptagrafft, who resides at the aforementioned incident location. The victim sustained a gunshot wound to the head area during the incident. C. Baker and P. Rossa also removed jewelry and cellphones from the residence during the incident. C. Baker and P. Rossa then stole the victim's vehicle, a 2004 Ford, green in color, bearing Fl. tag# S982HG, and then traveled in the vehicle along with the victim to Flagler County. They attempted credit card transactions at the Suntrust Bank and Winn Dixie ATM's, trying to withdraw U.S. Currency with the victim's credit cards. C. Baker and P. Rossa then drove the vehicle to Black Point Road in Bunnell. They then stopped the vehicle less than one mile from the intersection of Black Point Road and SR100. C. Baker then exited the vehicle from the drivers' side front door. The victim then exited the vehicle from the driver's side back door. The victim proceeded to run from the vehicle and C. Baker. C. Baker began to follow the victim into the woodline and was approximately fifteen feet behind her. As the victim was running from C. Baker, he shot once at the victim and then two more times as she fell to the ground. C. Baker and P. Roosa left the area and traveled to Bunnell. Randy Burke in the victim's vehicle traveling southbound on S.R. U.S. 1 near the Bunnell Shopping Plaza. Sgt. Burke attempted a traffic stop on the vehicle at which time they fled eastbound on Martin Luther King Blvd were subsequently apprehended.

During a Post Miranda videotaped statement C. Baker confessed to the aforementioned incident and the murder of the victim, Elizabeth Uptagrafft. C. Baker stated during the interview that if he was going to get in trouble that he was going all the way and that is why he murdered her. During the interview C. Baker pointed out on a map, the location of where he shot the victim. C. Baker was then transported to the area on the map and the victim's body was subsequently located a mile from SR 100 on Black Point Road. The body was approximately fifty feet from the roadway in the woods.

Note: The victim's Bank of America Credit Card was found on the person of P. Rossa at the time of apprehension.
