Narrative

On 09/16/2023 at approximately 0333 Hrs. I, Deputy Bolling, was escorting Nurse Roberts and medical staff to cell O-3 to evaluate Inmate Barry, Sean BK#23-2252 in reference to vocalization of experiencing pain (Ref Incident #00001625). Upon approaching cell O-3, of which Inmate Barry was the sole occupant, I saw Inmate Barry Suspended by his neck from a sheet that he had tied around the top bunk. I immediately called a CODE WHITE in Oscar block Housing Unit with instruction to bring the ligature tool. I called the door via my Agency Issued Radio and the aforementioned medical staff, and I entered cell O-3. Seeing that the sheet was not tied around his neck but twisted, I untangled the sheet from around Inmate Barry's neck. As I did, Inmate Barry was unresponsive and was brought to the floor of cell O-3 on his back. I detected no vital signs present attempted a sternum rub and instructed the Nurse to start CPR. Deputy Christensen instructed Annex Control to call for EMS response via his Agency Issued Radio. Deputy Estep retrieved the AED and brought it to cell O-3. Deputy Christensen cut Inmate Barry's shirt to reveal his bare chest, and the nurse applied the AED to Inmate Barry. I continued to monitor vitals and replaced the Nurse in performing CPR. I contacted Annex Control and requested them, via my Agency Issued Radio, to inform EMS that CPR was in progress. Deputy Saunders arrived with the oxygen tank and additional staff. I performed CPR for several rotations. Once fatigued, Deputy Christensen took my place and performed CPR for several rotations. Cpl Descartes arrived while managing logistics and traffic to the scene. Once Deputy Christensen was fatigued, I replaced him in performing CPR for several rotations. Once fatigued, I was replaced by the Nurse to Perform CPR for several rotations. Deputy LuLu arrived on scene, having escorted EMS through the facility. EMS then took over the scene and rendered aid to Inmate Barry. Once EMS felt safe to do so, Inmate Barry was placed on a mobile stretcher once a pulse was acquired. Cpl. Descartes cleared the CODE WHITE at approximately 0356 Hrs. Deputy Christensen escorted EMS in transporting Inmate Barry to Advent Health South. End of report.
