After placing Devarus in my car, **Experime** Aunt Michelle Gilmore, arrived on scene to be with **SGT** Gamarra advised that Devarus stated the argument was verbal in nature and that nothing physical had occurred. SGT Gamarra further advised that **SGT** stated Devarus was upset with her because she wanted them to break up. Deputy Ray stood by my vehicle with Devarus so that I could make contact with another male in the driveway.

The male, Val Mateyshin, was positively identified by his Florida Driver's License. Val advised that he was there to pick Devarus up due to Devarus and having a "full blown argument". Val advised that Devarus called his girlfriend (Val's girlfriend) to come and pick him up. Val further advised that the entire time he was enroute, he was on the phone with Devarus and he could hear shouting and doors slamming, never visually witnessing the altercation. Val then advised that when he arrived, he observed setting into the driver's seat of her vehicle with her baby in her arms. Devarus then went up to the driver door of her vehicle and took his shirt off, continuing to scream at her. Val advised setting then went back into the residence while Devarus ran around the back and continued to scream and slam doors. Val declined to fill out a Sworn Written Statement but my interaction with him was captured on my Axon camera. Val gave a similar statement to SGT Gamarra on AXON BWC which SGT Gamarra had Val swear to.

Once inside the residence, I made contact with **Sector** who was speaking with SGT Gamarra. **Sector** advised that she and her live-in boyfriend of approximately one year, Devarus, grabbed her by the hair while she was sholding her 2-year old daughter **Sector**. In a written statement, **Sector** advised that she asked Devarus about bills which upset him and caused him to become "flustered" and begin screaming. She then walked into the kitchen where Devarus grabbed her by the hair and cornered her, not letting her pass. She advised Devarus began threatening her with a pair scissors causing **Sector** to fear for her life. **Sector** stated that be walked from the kitchen to the living room with Devarus following behind her. **Sector** stated that Devarus picked up a silver colored glass vase and threw it at her, hitting the ground in front of her, further making her fear for her life, all while she was holding her child. It is to be noted that though it is not written in the statement, **Sector** advised SGT Gamarra that Devarus was waving the scissors in her direction in a threatening manner while walking towards her, striking her in the finger causing **Sector** to bleed.

Stated that while this assault and battery was taking place, and throughout the incident, that Devarus was making the statement "I'll kill you over my feelings". Stated that when the argument started, she went to her security pad to secretly summons law enforcement, as she was scared that the situation would escalate. Stated that Devarus pulled her away from the keypad at which time she informed him she would contact law enforcement on her cellular telephone. Stated that Devarus took her cell phone away from her. Stated that she then texted 9-1-1 from her daughter's cell phone. Throughout the incident, Stated that she was in fear of Devarus, and thought that he would hurt her. Stated that there is a long, undocumented history of domestic violence incidents between her and Devarus.

advised she then attempted to walk out the front door. Upon her opening the door, Devarus kicked the door shut blocking her ability to exit the residence. **Second** then walked through the garage door where she entered her vehicle in order to text 911 for assistance from Law Enforcement. **Second** advised that Devarus followed her the entire time to her car and was screaming at her until texted 9-1-1 and returned inside the residence. Shortly after, SGT Gamarra arrived on scene and detained Devarus for safety reasons. SGT Gamarra advised that Devarus was reaching inside his pockets, and having to monitor three separate subjects on scene while being the only deputy at the residence, SGT Gamarra detained Devarus immediately for officer safety.

Efforts were made to recover the scissors, however, it is believed that Devarus placed the scissors in a backpack within Val's vehicle, unbeknownst to Val, who had been released as law enforcement had completed an interview with him, and had no further legal reason to hold him at the residence. Efforts to locate Val at his residence were made with negative results.

Upon conducting a Criminal History inquiry, Devarus was found to have 1 previous conviction of Battery in
