**1) HOW VIOLATION OCCURRED:**

The subject was instructed that there was no excuse for her to not report due to distance and the subject was instructed to report by 2 P.M. today with the purchase contract to the new property and to fill out an updated written monthly report with her new address or the court will be notified of the violation. The subject stated she will report and understood. At approximately 14:27 P.M., the subject called this officer asking if we needed a copy and the subject was instructed to bring the deed and we will review it.
