- Entry Deadline: Monday, November, 30, 5 p.m. Must be received by Event Captain Robert Ulis electronically at THEULISES@ATT.NET or deposited in Yacht Club box outside front door.
- Route: Arrive 5:45 p.m at Cimmaron Basin to depart at 6 p.m. Boats depart Cimmaron Basin to ICW, turning south passing Tidelands, Canopy Walk, St. Joe's Walkway, Waterfront Park Island Estates, and Grand Haven. Boats turn at Grand Haven Gazebo before turning north dispersing at entrance to Clubhouse Waterway.
- Boat Captains Meeting: **REQUIRED ATTENDANCE!!** December 5, 2015, 10 a.m. Palm Coast Yacht Club, 1 Yacht Club Drive, Palm Coast
- General Directions: All boats must be lit and decorated with a Holiday/Christmas Theme. Vessel must carry operable regulation running lights and must be able to travel under power at 5 knots the full distance of the Parade Route (3.8 statute miles), carry an operable VHF radio and proof of insurance and registration.
