MOTION TO REVOKE BOND

COMES NOW, the State of Florida, by and through the undersigned Assistant State Attorney, and pursuant to Fla. Statue 903.0471, hereby moves this Honorable Court to revoke the present bond of the defendant because there is probable cause to believe the defendant committed a new offense while on pretrial release in this case. Specifically, the State would show:

- 1. An arrest warrant was issued in this case for Sexual Battery Victim Under 18 years, a first degree felony, by the Honorable Judge Moore Stens, on May 13, 2020. Judge Stens issued a bond of \$100,000 along with no contact provisions.
- 2. The defendant was subsequently arrested on said warrant on May 20, 2020, and was released from custody that same day after posting the \$100,000 bond.
- 3. The defendant, while out on bond in this case, was arrested on a warrant in Volusia County on January 26, 2021, for the offenses of Aggravated Assault with a Deadly Weapon, a third degree felony, and Fleeing and Eluding Lights and Siren Active, a third Degree Felony. Said offense is alleged to have taken place on December 26, 2020, in Volusia County. A copy of the 707 for that offense has been attached to this motion for the Court's review. That case is now pending in Volusia County, case number 2021-300480CFDB.
- 4. Because there is now probable cause to believe that the defendant has committed a new crime while on Pre-trial release, as contemplated in Fla. Statute 903.0471, the State requests that this Court revoke Defendant's bond and hold him in custody until the instant case is resolved.

WHEREFORE, the State of Florida respectfully requests this Court enter an Order revoking the defendant's bond, and hold the defendant in custody until the instant case is resolved.
