The undersigned certifies and swears that there is probable cause to believe the above named defendant, <u>In June or July 2016, unknown exact date</u> <input checked="" type="checkbox"/> a.m. <input type="checkbox"/> p.m. at [REDACTED] within <u>Flagler</u> County, violated the law and did then and there:					
<p>On an evening in June 2016, the victim was staying at the above stated residence with a friend; she was there to spend the night as well. During the evening, the victim, her friend, (Witness) and friends stepfather, (here in after referred to as the "defendant"), were playing games together in the friend's bedroom. While playing these games, it was agreed upon that the loser of each game would have to do something as determined by the winner. When the victim lost a game the defendant told her, "Down the hall and unlock the right door," which the defendant explained to her clearly to expose her right breast; which she did, however her breast was covered by her bra. When the defendant lost again, the defendant had her expose both her bare breasts, after which the defendant stated to the victim, "You have a nice pair." The victim stated that she observed the defendant kiss her friend on the lips and touch her breasts and her friend said she was used to her stepdad being a "perv."</p> <p>The defendant then explained that they began playing a game called, "7 Minutes of Heaven," with both girls. The victim explained when she and the defendant were in the closet of her friend's bedroom alone the defendant placed his mouth on her bare breast, while his hands were on her legs. Shortly after, the victim's friend opened the closet door and told the victim and defendant that time was up. On a second occasion, the victim and defendant were in the closet alone, with the door closed; the victim said she was sitting in a chair when the defendant "took his pants off" and the</p>

defendant began "Jacking Off" in front of her. It should be noted that the victim explained that Jacking Off was where the defendant was moving his hand back and forth on his exposed penis, she further demonstrated what the defendant was doing by showing the interviewee her own hand moving back and forth. The victim continued to say that the defendant placed his hand on her head, she heard him breathing heavy while he continued to "Jack Off." The defendant asked the victim, "When I'm finished, where do you want me to put it?" The victim then stated, "After a few minutes, I felt something really wet on my arm." When asked if his penis touched her, she responded, "No, just something sprayed on my arm and it felt warm." The Victim, when asked, stated that he said to her not to say anything saying, "What happens in Vegas, Stays in Vegas." The defendant also said that she would be smart not to tell anyone.

On September 20th 2016 at approximately 1430 hours CSI Weibling, Detective J. Glasgow and I responded to [REDACTED] 32110. Detective J. Glasgow and CSI Weibling were examining the chair and table, which were previously in the closet as well as the chair that Cydni was sitting in during the incident, while I looked in the closet. While looking in the closet I located on the wall, to the left of the closet door, what appeared to be several small drops of dried fluid? I pointed out the spots to CSI Weibling and she used her Ultra Violet alternative light source, which became fluorescent under the light to CSI Weibling. CSI Weibling then conducted a Semen Presumptive test on one of the stains, which came back presumptive positive for semen. The stains were then collected for further analysis by CSI Weibling and entered into evidence under item #515.2. See CSI Weibling's detailed report attached to the case file.

On September 28th 2016 I conducted an interview with the Defendant, he knew of the victim we were discussing as well as the incident that occurred. The defendant admitted to being in his stepdaughter's bedroom playing cards with both girls; however, he could not remember the exact date. The defendant also admitted to being a loser of a game and swallowing a spoon of hot sauce as result. When asked if he went in the closet, he responded, "Hell no I didn't go in the closet," though he admitted to being in there on previous occasions, but only to retrieve a pair of scissors or sit in the chair when his stepdaughter first got it, other than that he does not go in there. The defendant further recalled the game "7 minutes in Heaven" when his stepdaughter described it; he said that he didn't play that and told them absolutely not. I also asked the defendant if there was any reason his semen would be in his stepdaughters closet, which he replied, "No, he has not had sex in there; he did have sex in his wife's brother's room, but not in there." At the end of the interview, I executed a DNA search warrant, where I obtained two buccal swabs from the defendant.

On December 1st 2017 at approximately 0816 hours I entered the FDLE LIMS PRELOG 100 Days report section and reviewed the report. The report results stated that a STR DNA analysis was performed on samples from Exhibits 1 and 2 utilizing the GlobalFiler PCR Amplification Kit. A complete DNA Profile was obtained from exhibit 2, (Michael Bowling's DNA) as well as a complete DNA Profile was obtained from exhibit 1, (Swab from wall and prepared slide). The DNA profile from exhibit 1 matches the DNA profile from Michael Bowling. The report also reported the DNA profile is greater than 700 billion times more likely to occur if the sample originated from Michael Bowling than from an unrelated individual. The DNA profile developed from Exhibit 1 has been entered into CODIS.
