hand. The knife was a black handled serrated kitchen knife. Brandon continued to approach Rodriguez and attacked him with the knife in a downward striking motion. Rodriguez was cut on his left upper chest area and his shirt was also cut. He was also cut on his left arm. Rodriguez was able to strike Brandon in the face and flee his room. Brandon continued to follow him throughout the house from the kitchen area into the rear porch area. Once in the rear porch area, Brandon threw several glass items at Rodriguez and dropped the knife on the ground. Rodriguez was able to flee out of the rear door of the residence and run to the road where he waived down a passerby to use their phone to call 911.

Rodriguez advised that he was in fear for his life when Robert brandished and attacked him with the knife.


Rodriguez suffered from injuries consistent with his story including what appeared to be knife inflicted slashes to his chest and left arm, and his shirt was ripped in a manner which was also consistent with his story.

Prior to arrival of law enforcement, Robert Brandon left the scene. He was located approximately one block way and placed under arrest. He refused to provide a statement on scene. A small laceration was observed under his left eye which was consistent with Rodriguez's story. Photographs were taken of Brandon's injury.

Sergeant Barile inspected and took photos of the inside of the residence. Upon investigation, a stick like object was observed stuck in the bedroom door, there were several holes in the door, a knife was in the wall to the right of the door outside the bedroom, blood smear was on the wall outside of the bedroom, blood droplets were on the floor of the kitchen, and there was shattered glass on the rear porch as well as a knife that contained blood. Several photographs were taken and uploaded to Aegis records by Sergeant Barile.

All interviews were recorded and the Axon footage will be uploaded to Evidence.com. Copies of the photographs were obtained to be attached to this charging affidavit.

Due to the totality of circumstances, Robert Brandon was placed under arrest for aggravated battery with a deadly weapon and transported to the inmate facility but due to his high alcohol level he was transported to Florida Hospital Flagler for medical clearance. After medical clearance he was transported to the inmate facility.
