

Utilizing the phone number for **Brandon** (386-986-6227), he was identified to be **Brandon Raymond (07/01/2005)**.

I, Detective Gordon, made contact with [REDACTED] in reference to the investigation [REDACTED] explained that she had located worn female underwear in KK's backpack that she normally takes to her friend's houses when she stays the night [REDACTED] explained that the underwear had stains on the inside of them [REDACTED] provided the underwear to me for a presumptive seminal fluid test to be conducted. CSI Supervisor MacLellan conducted a presumptive seminal fluid test on the underwear, at which time it was positive.

A Child Protection Team (CPT) interview was conducted with KK. During the CPT interview, KK disclosed the following:

- KK and **Brandon** have been dating for approximately three (3) months. **Brandon** is 20 years of age.

**Brandon** is aware of KK's age:


- KK and **Brandon** communicate through Instagram, text message, and Snapchat.
- KK and **Brandon** have had sex on multiple occasions. KK explained that **Brandon** kept asking her to engage in sexual activity with him.
  - KK explained that the first time they had sex, in August of 2025, it was at one of their mutual friends' houses in Palm Coast, while in a bedroom. KK stated that **Brandon** did not use protection and came into a towel. KK advised that the friend was "Annalynn".
  - Approximately one (1) month ago was the most recent time that KK and **Brandon** had sex. KK explained that **Brandon** picked her up in his vehicle, a "grey" vehicle, and they had sex in the backseat of the car. KK stated that **Brandon** did not use protection and came onto the seat of the vehicle.
- KK uses a birth control patch.
- It should be noted that KK was shown a picture of the underwear provided by [REDACTED] KK was unable to say if those were her underwear or not.

The underwear provided by [REDACTED] along with KK's buccal swab, was submitted to the Florida Department of Law Enforcement (FDLE) for biological analysis.

**Brandon** was found to have multiple law enforcement contacts while driving a silver Kia Soul, bearing Florida tag QBRD69. This Kia Soul is registered to Diana Burnside, who has the same registered address as **Brandon** (38 Port Royal Drive, Palm Coast, Florida). Since March 2025, **Brandon** has had contact with law enforcement while driving the silver Kia Soul. During two (2) of these contacts, **Brandon** had a female juvenile in the vehicle with him.

Contact was made with [REDACTED] on October 7, 2025. [REDACTED] stated that on October 1, 2025, she logged into KK's Snapchat and saw that KK and **Brandon** were actively communicating. Additionally, on October 8, 2025, KK was found to have an additional cell phone. It is unknown where this cell phone came from. [REDACTED] took this cell phone from KK and turned it over to law enforcement for a forensic download. The following information was obtained through KK's second cell phone download:

On October 8, 2025, your Affiant obtained a search warrant for the Silver Kia Soul, bearing Florida tag QBRD69. The said search warrant was obtained for biological evidence in the backseat of the vehicle. Additionally, Your Affiant obtained a search warrant for a standard of **Brandon's** DNA. Both of the search warrants were signed by Honorable Judge Upchurch.

Your Affiant also obtained a search warrant for **Brandon's** person to seize his cell phone, bearing phone number **386-986-6227**. Honorable Judge Upchurch signed this search warrant on October 8, 2025.

On October 10, 2025, Corporal Breckwoltd and I, Your Affiant, made contact with **Brandon** in the Publix parking lot (414 Beach Village Drive, Flagler Beach, Florida 32136). It should be noted that this was a consensual encounter with **Brandon**, and upon asking if we could speak with him, he agreed. During our conversation, **Brandon** stated the following:

- **Brandon** and KK met through Instagram and began communicating over Instagram. They also used Snapchat and text messages to communicate with one another.
- When they began seeing each other, around July 2025. **Brandon** stated that he originally thought that KK was 17 because of the ages of her friends; however, in late July or early August, he found out she was actually 15.
- Upon discovering KK was 15 years of age, **Brandon** wanted to end the relationship with KK but did not want to "hurt her" emotionally, so they continued.
- **Brandon** and KK had sexual intercourse on at least two (2) occasions.
  - At least one of these occasions was in his vehicle, the Silver Kia Soul, near the Walmart area of Palm Coast.

- Another time was at one of their friends' houses, in Palm Coast.
- On multiple occasions, **Brandon** expressed that he was secretive about their relationship with others due to her age.
- **Brandon** stated that he has spoken to KK through text message within the past week.
  - It should be noted that her first cell phone was taken on September 16<sup>th</sup>, 2025, and her second cell phone was taken on October 8<sup>th</sup>, 2025.
- **Brandon** stated that a person texted him on October 10<sup>th</sup>, 2025, claiming to be KK.
- **Brandon** explained that he had a letter from KK in his vehicle.


**Brandon** was advised of his Miranda Rights and reiterated the statements above. I asked for **Brandon's** cell phone number, at which time he provided the following: **386-986-6227**. I sent a text to the phone number provided and saw the notification on his cell phone. I asked **Brandon** to hand me his cell phone, and he did. I read **Brandon** the search warrant for his person to seize his cell phone and DNA. A buccal swab was also obtained. **Brandon** was read the vehicle search warrant as well. The Kia Soul was secured and towed to the Flagler County Sheriff's Office for forensic processing. The cell phone was turned over to the Digital Forensics Unit.

On October 14, 2025, your Affiant obtained an amended search warrant for the vehicle to obtain the letter written by KK, along with biological evidence. This search warrant was signed by Honorable Judge France.

Crime Scene Investigator (CSI) Massa, CSI Centeno-Negron, CSI Butler, and I, Your Affiant, executed the search warrant on the Kia Soul. While processing the vehicle with an alternate light source (ALS), multiple items of clothing were located in the trunk of the vehicle that had biological evidence on them, as well as many parts of the backseat. The clothing, backseat fabric, and KK's letter were seized from the Kia Soul.
