  - Chamber Financials Statement Review July 2019
- July's Financial Statement Review
  - o End of month cash balance \$2,252.88
  - P&L came in at 1.7K (uf) versus budget. Driven by lower than expected advertising dollars.
  - YTD Net income came in at \$32K (uf) versus budget. We expect to make the difference in Q4 with higher than expected performance from Smart City, Creekside, and Fantastic Flagler Magazine performance versus budget.
- Jorge Gutierrez
  - o Progress 2019 Strategic
    - Focus is on revenue growth and cost reduction.
    - Cash continues to be a serious concern. Discussed with executive committee the need for me to go on a part time basis to build cash reserve. Jorge has funded two weeks worth of payroll at this rate he recommended to switch to part time. Allen Goodman asked how much is owed to Jorge and Robbin. Jorge is approximately \$7K and Robbin about \$2K. Exact figures can be determined with our third party payroll provider.
    - Line of credit was submitted to Intercostal Bank and approved.
