NARRATIVE		The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the <u>11th</u> day of <u>September</u> , 2018, at approximately <u>0000-0900</u> <input checked="" type="checkbox"/> a.m. <input type="checkbox"/> p.m. at <u>12 Big Bear Lane</u> within <u>Flagler</u> County, violated the law and did then and there:			
<p>Charge 1: Sexual Battery- Victor Eugene Williams did travel to the intersection of Birchwood Drive and Biltmore Place at approximately 2330 hours on September 10th, 2018. Victor picked up minor child, ED, from the intersection and drove him back to his (Victor's) residence located at 12 Big Bear Lane. While at Vectors house, ED was given alcoholic beverages described as possibly a "Margarita" and (4) Locos beer. After consuming the alcoholic beverages, ED stated he was given an orange rectangular pill (unknown what type of pill) and then he began to feel extremely disoriented and went unconscious. ED recalls waking up to the male licking his anus without his consent. Furthermore, a sexual assault exam was completed. The victim does not have clear memory of anal penetration but has anal bleeding and significant pain on the exterior and interior of his anus. All of these sexual incidents occurred without the consent of the juvenile victim and furthermore the victim is not of age to consent to a person 42 years of age due to only being 16 years of age.</p> <p>During a controlled telephone call between Victor Williams and Nicole Hartline, Victor Williams admits to sexual anal intercourse with victim, ED. Victor also admits to providing the juvenile with alcoholic beverages and having to care for him because he was so intoxicated while they were together.</p>
