**ORDER OF CONTEMPT AS TO JAMES CIGLER AND
WRIT OF BODILY ATTACHMENT**

THIS CAUSE having come before this Court on an Order to Show Cause hearing, and JAMES CIGLER, appear on behalf of and submitting to jurisdiction and responsibility for TERRANCE BRYANT, having been ordered to complete the Fact Information Sheet and return such notarized to the Plaintiff within TWENTY (20) days of the hearing, and the Defendant JAMES CIGLER having failed to complete the Fact Information Sheet after being ordered to do so by this Court, it is ORDERED that:

1. The Defendant JAMES CIGLER is found in civil contempt for the above-stated noncompliance.
- 2 THIRTY days after the date of this order, EACH SHERIFF OF THE STATE OF FLORIDA is hereby COMMANDED to take into custody JAMES CIGLER and place him in Flagler County Jail until he may be brought before Judge Christopher A. France, in the Flagler County Courthouse located at 1769 E. Moody Blvd, Bunnell, Florida. This Writ shall be promptly served and executed BETWEEN THE HOURS of Monday through Friday (LEGAL HOLIDAYS EXCLUDED) and shall expire and terminate if not served within 60 days of the date of this Writ. In rare instances when the Defendant is taken into custody during normal court hours but cannot, after diligent effort, be brought before a judge on the same date this Writ is served, the Defendant may be confined in the Flagler County Jail until the earliest possible time that he can be brought before the Court, no more than 3 days.
3. Upon execution of this Writ, the Sheriff shall promptly notify, by telephone, AND DURING OFFICE HOURS, the office of the undersigned Judge at (386) 313-4520.
4. **AS AN ALTERNATIVE TO BEING TAKEN INTO CUSTODY AND TO SECURE RELEASE, the Defendant JAMES CIGLER may post a CASH PURGE in the amount of \$2,290.50** with the Clerk of Court which may be disbursed to the Plaintiff/judgment creditor upon

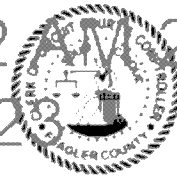
the Defendant's failure to promptly cure the above noncompliance after hearing before the Court and appropriate court order.

5. The Defendant JAMES CIGLER may purge this contempt by serving the completed and executed Fact Information Sheet (attached) on the Plaintiff within thirty (30) days from the date of service of this Order and prior execution of the Writ.
