

Synopsis				
<p>This investigation is predicated upon receipt of a complaint submitted by the COMPLAINANT Morgan who alleges that on 03/12/2017 he contracted with the SUBJECT Cigler DBA The Gutter Guy for remodeling services of the exterior of the home, which included the replacement of cedar plank siding and the replacement of the soffit at his residence located at 716 North Central Avenue, Flagler Beach, FL 32136 for a total amount of \$7,500.00 without the proper state licensure. The COMPLAINANT alleges that the SUBJECT was paid \$17,500.00 via checks; the SUBJECT never completed the work; no permit was obtained for the work; and the SUBJECT kept requesting additional monies (Exhibit 1).</p> <p>On 05/15/2017 Investigator Jared Spong notified the SUBJECT of the allegations via US Mail to 59 Pony Express Drive, Palm Coast, FL 32164 and on 06/05/2017 it was returned as the forward time expired and returned to sender. On 06/06/2017 Investigator Jared Spong notified the SUBJECT of the allegations via US Mail to the address above, as it was listed as the forwarding address (Exhibit 2). The SUBJECT was provided with copies of the documents contained in Exhibit 1.</p> <p>Versa licensing records reveal that the SUBJECT DBA The Gutter Guy is not licensed to perform any construction services. Florida Division of Corporations indicates the SUBJECT as the Owner of Fictitious Name The Gutter Guy, which is in an Active status effective 08/31/2015. City of Palm Coast Business Tax Receipts lists the SUBJECT as the Owner of The Gutter Guy, #15088, which is actively operating. All licensing records are attached (Exhibit 3).</p> <p>The SUBJECT was not known to be represented by counsel during the course of the investigation.</p> <p>As of the date of this report, the SUBJECT has not requested a copy of this investigation.</p>
