**Background:**

The Flagler County Sherriff's Office has requested to integrate several of the City of Palm Coast's cameras into FUSUS, their Real Time Crime Center Platform. To accommodate this request, staff are proposing entering into an agreement with Axon to implement the FUSUS Real-Time Crime Center (RTCC) platform. This platform will serve as a vital bridge between City infrastructure and law enforcement by enabling the secure, real-time sharing of City-owned camera feeds. It ensures rapid access to visual data during incidents while preserving the City's autonomy over its surveillance systems.

Implementing the FUSUS platform directly—rather than through a third party—empowers the City to retain full control over its camera hardware, configurations, and cybersecurity posture. This control is critical in maintaining a secure and resilient infrastructure, particularly as digital threats continue to evolve. The City can manage device access, conduct timely software updates, and remove any devices from the network in response to threats or changes in operational needs. Additionally, by controlling the platform settings, the City ensures that camera configurations are not inadvertently overridden or altered by outside entities.

For the Flagler County Sheriff's Office, the integration of City-owned cameras into the FUSUS RTCC platform significantly enhances their operational effectiveness. Deputies patrolling Palm Coast will gain faster insight into active calls for service through access to live or retrospective video. This capability can reduce response times, improve officer safety, and support investigative efforts with verifiable visual evidence. Instead of relying solely on verbal reports or 911 call descriptions, responding units can access a visual context of incidents, leading to more informed and precise action in the field.

Furthermore, this platform lays the foundation for smarter and more connected city operations. It can evolve to support data integration from traffic systems, and additional sensor-based technologies. As Palm Coast continues to invest in smart infrastructure, owning and managing this platform gives the City the flexibility to expand its capabilities in alignment with strategic goals while ensuring compliance with public records laws and data

governance standards.

The cost to start the implementation this year is \$31,475 and is being funded through the usage of IT contingency funds along with savings that have been realized in the current year's budget.



**RESOLUTION 2025-\_\_\_\_**  
**PIGGYBACKING SOURCEWELL CONTRACT**  
**WITH AXON ENTERPRISE, INC**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM COAST, FLORIDA, APPROVING PIGGYBACKING THE SOURCEWELL CONTRACT (101223-AXN) WITH AXON ENTERPRISE, INC., FOR REAL TIME CRIME CENTER SOFTWARE, CAMERA MANAGEMENT, HARDWARE, SUPPORT AND RELATED SERVICES; AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE SAID CONTRACT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR IMPLEMENTING ACTIONS AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Axon Enterprise, Inc., has expressed a desire to provide a Real-Time Crime Center platform, related hardware, support and services to the City of Palm Coast; and

**WHEREAS**, the City Council of the City of Palm Coast desires to approve piggybacking the Local Government Purchasing Cooperative (“Sourcewell”) contract with Axon Enterprise, Inc., for a Real-Time Crime Center platform, related hardware, support and services.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM COAST, FLORIDA AS FOLLOWS:**

**SECTION 1. LEGISLATIVE AND ADMINISTRATIVE FINDINGS.** The above recitals (whereas clauses) are hereby adopted as the findings of the City Council of the City of Palm Coast.

**SECTION 2. APPROVAL OF PIGGYBACK.** The City Council of the City of Palm Coast hereby approves piggybacking the contract between Local Government Purchasing Cooperative (“Sourcewell”) and Axon Enterprise, Inc., for a Real Time Crime Center platform, related hardware, support and services as attached hereto and incorporated herein by reference as Exhibit “A.”

**SECTION 3. AUTHORIZATION TO EXECUTE.** The City Manager, or designee, is hereby authorized to execute the necessary documents.

**SECTION 4. SEVERABILITY.** If any section or portion of a section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other section or part of this Resolution.

**SECTION 5. CONFLICTS.** All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

**SECTION 6. IMPLEMENTING ACTIONS.** The City Manager is hereby authorized to take any actions necessary to implement the action taken in this Resolution.

**SECTION 7. EFFECTIVE DATE.** This Resolution shall take effect immediately upon adoption by the City Council.

**INTENT TO PIGGYBACK OFF COOPERATIVE PROCUREMENT**

**Sourcewell Contract #101223-AXN**

This agreement (“the Agreement”) is hereby made this 5th day of May, 2025, by the City of Palm Coast (“Agency”) and Axon Enterprise, Inc. (“Axon”). Collectively, Agency and Axon are the “Parties.”

WHEREAS, the Agency desires Axon to provide certain products and services as described on Quote Q-681313-45757.778SH; and

WHEREAS, Axon is a party to Sourcewell #101223-AXN with The Local Government Purchasing Cooperative (“Sourcewell”) dated February 6, 2024, related to “Public Safety Video Surveillance Solutions with Related Equipment, Software and Accessories from which Supplier” (the “Sourcewell Contract”), which is incorporated herein by reference; and

WHEREAS, Axon has agreed to provide goods and services within the scope of the Sourcewell Contract to the Agency at the same prices chargeable to Sourcewell; and

WHEREAS, the goods and/or services required by the Agency and that the Agency seeks to obtain from Axon are within the scope of the Sourcewell Contract; and

WHEREAS, it is the purpose of this Agreement to describe the formal rights and obligations of the parties;

NOW, THEREFORE, WITNESSETH that, for the consideration herein indicated, and in consideration of the mutual promises and covenants set forth in this Agreement, the Parties Agree as follows:

1. The Parties intend to utilize the Sourcewell Contract for the goods and services detailed in Quote Q-681313-45757.778SH (the “Quote”) which is incorporated into this Agreement and attached hereto as Exhibit A.
2. The City of Palm Coast Engagement Letter is incorporated into this Agreement, attached hereto as Exhibit B.
3. The City of Palm Coast Engagement Letter Addendum is incorporated into this Agreement, attached hereto as Exhibit C.
4. The Axon E-Verify Affidavit is incorporated into this Agreement, attached hereto as Exhibit D.
5. The Axon Affidavit of Compliance with Anti-Human Trafficking Laws is incorporated into this Agreement, attached hereto as Exhibit E.
6. The Axon Foreign Country of Concern Attestation Form (PUR 1355) is incorporated into this Agreement, attached hereto as Exhibit F.
7. Sourcewell Contract #101223-AXN is hereby incorporated into this Agreement, attached hereto as Exhibit G.
8. Sourcewell Contract #101223-AXN 2025 Pricebook is hereby incorporated into this Agreement, attached hereto as Exhibit H.
9. The term of this Agreement shall begin upon the date of last signature and shall continue until all subscriptions hereunder have expired or have been terminated. In the event the term of the subscriptions extends past the termination or expiration of the Sourcewell Contract, the terms and conditions of the Sourcewell Contract shall remain in full force and effect as it applies to the Quote and will continue in effect for such order until the term of that Quote expires or the order is cancelled or terminated in accordance with the terms of this Agreement.
10. The term of this Agreement shall begin upon the date of last signature and shall continue until all the expiration of the term specified within the Quote. In the event the term of the subscriptions

extends past the termination or expiration of the Sourcewell Contract, the terms and conditions of the Sourcewell Contract shall remain in full force and effect as it applies to the Quote and will continue in effect for such order until the term of that Quote expires or the order is cancelled or terminated in accordance with the terms of this Agreement.

This Agreement, together with Sourcewell Contract #101223-AXN, constitutes the entire agreement between the parties relating to the subject matter of this Agreement. All prior understandings, agreements, correspondence and discussions of the parties are merged into and made a part of this agreement. To the extent that the terms of the documents conflict, the terms of this Agreement shall control.

This Agreement may be executed by the Parties by facsimile and in counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.






