(1) HOW VIOLATION OCCURRED:

Violation of Condition (15B) of the Order of Modification of Probation, by using intoxicants to excess or possessing any drugs or narcotics, unless prescribed by a physician, and as grounds for belief that the offender violated her community control, Officer Foggie states that on 11/09/2021, the offender did test positive for Benzoylecgonine-Cocaine Metabolite on a urine drug test as administered by Officer Foggie. Additional confirmation for drug use was confirmed by Alere Labs. Alere Labs confirmed the presence of Benzoylecgonine-Cocaine Metabolite on 11/15/2021.

Circumstances: The offender reported to the probation office for routine weekly community control visit. While at the probation office, the offender was drug tested for Benzoylecgonine-Cocaine Metabolite by this officer. The offender did test positive for Benzoylecgonine-Cocaine Metabolite. The offender denied drug use and stated, "my boyfriend uses cocaine, but I don't use cocaine." Because the offender denied use, this officer sent the offender's drug test result to Alere Labs. On November 15, 2021, Alere Labs confirmed the presence of Benzoylecgonine-Cocaine Metabolite.

The offender attended group sessions on 10.27.2021 and 11.03.2021; However, the offender failed to attend group session on 10.20.2021.

(4) **RECOMMENDATION:**

A warrant is being requested for the offender. As mentioned herein, the offender tested positive for Benzoylecgonine-Cocaine Metabolite and denied use. The offender's test result was confirmed by Aere Labs to be positive for drug use. The offender has violated her order of community control by failing to comply with the stipulations in her orders: by using intoxicants to excess or possessing any drugs or narcotics, unless prescribed by physician; by failing to abstain entirely from the use of alcohol and/or illegal drugs. This is not the offender's first-time being in violation of her probation as the offender has incurred numerous violations over the course of her years on community based supervision. Based off the offender's previous and current behavior, the offender appears to be persistently showing a propensity, for being disingenuous. This officer is respectfully recommending that the offender be sentenced to a period of incarcer trion deemed appropriate by the court. Should the court decide otherwise to place the offender back on community-based supervision, the offender should be considered and evaluated for the Flager County Adult Drug Count Program.
