At this time I (Cpl Miller) believe that there is probable cause that Dorian Buzz Coppedge has knowingly and intentionally violated at least two (2) conditions of Florida's Sex Offender Registration Laws. Specifically 943.0435 (2) and 943.0435(3) which state:

### COUNT 1:

**943.0435 (2) A sexual offender shall:**

**(a) Report in person at the sheriff's office:**

- 1. In the county in which the offender establishes or maintains a permanent, temporary, or transient residence within 48 hours after:**
  - a. Establishing permanent, temporary, or transient residence in this state; or**
  - b. Being released from the custody, control, or supervision of the Department of Corrections or from the custody of a private correctional facility; or**
- 2. In the county where he or she was convicted within 48 hours after being convicted for a qualifying offense for registration under this section if the offender is not in the custody or control of, or under the supervision of, the Department of Corrections, or is not in the custody of a private correctional facility.**

Any change in the information required to be provided pursuant to paragraph (b), including, but not limited to, any change in the sexual offender's permanent, temporary, or transient residence, name, electronic mail addresses, or Internet identifiers required to be provided pursuant to paragraph (4)(e), after the sexual offender reports in person at the sheriff's office, must be accomplished in the manner provided in subsections (4), (7), and (8).

### COUNT 2:

**943.0435 (3)**

**(3) Within 48 hours after the report required under subsection (2), a sexual offender shall report in person at a driver license office of the Department of Highway Safety and Motor Vehicles, unless a driver license or identification card that complies with the requirements of s. 322.141(3) was previously secured or updated under s. 944.607. At the driver license office the sexual offender shall:**

**(a) If otherwise qualified, secure a Florida driver license, renew a Florida driver license, or secure an identification card. The sexual offender shall identify himself or herself as a sexual offender who is required to comply with this section and shall provide proof that the sexual offender reported as required in subsection (2). The sexual offender shall provide any of the information specified in subsection (2), if requested. The sexual offender shall submit to the taking of a photograph for use in issuing a driver license, renewed license, or identification card, and for use by the department in maintaining current records of sexual offenders.**

**In reference to COUNT 1, the following facts are established in the proceeding Investigative Summary:**

- **Dorian Coppedge has knowingly and intentionally registered 41 Louisiana Dr, Palm Coast FL, 32137 as his permanent address.**
- **He in fact lives at 309 S Chapel St Bunnell, FL with a female named Lucianne Spearmon.**
- **He has not register 309 S Chapel St, or any other address as a temporary address in violation of Florida Sex Offender Registration Law 943.0435.**
- **His phone records show that he is located in the area of 309 S Chapel St, most days, and rarely, if ever at 41 Louisiana Dr.**
- **Dorian, and the only vehicle registered to him (a 1987 Volvo), have been routinely seen and documented at 309 S Chapel St.**
- **During his registrations he routinely provided a phone number (1 digit off) from the actual phone he uses, in violation of Florida Sex Offender Registration Law 943.0435 most likely to avoid detection.**
- **He has failed to report several vehicles which he has access to at both his claimed permanent address and the address he actually lives at (309 S Chapel St) in violation of Florida Sex Offender Registration Law 943.0435.**
- **He also maintains an internet identifier that he has never disclosed during registrations, in violation of Florida Sex Offender Registration Law 943.0435.**
- **Dorian has signed multiple registrations indicating that he understands and acknowledges his requirements for registration.**

**In reference to COUNT 2, the following facts are established in the proceeding Investigative Summary:**

- **Dorian uses 309 S Chapel St as his permanent address but shows 41 Louisiana Dr as his residence on his Florida Driver's License.**
- **He recently had his license reinstated on 2/19/16 and again provided the Louisiana address as his residence.**
- **He has not changed the address on his license within the 48 hour time frame required by Florida Sex Offender Registration Law 943.0435**

## Investigative Summary

Items listed in red are documents uploaded into the Flagler County Sheriff's Office Records Management System.

Items listed in blue are items submitted to evidence.

### Initial Investigation

On 11/24/15 I (Cpl Miller) opened an investigation for Dorian Coppedge, for a possible violation of sex offender registration laws. A preliminary investigation showed that Dorian has been registering 41 Louisiana Dr since 1/9/14 and he does not list any temporary addresses. A search of the Florida Offender Registration and Tracking System (FORTS) showed that the address was last verified on 1/25/14 by Dep Cowan. A search of internal agency records shows that the address was last verified on 1/25/15. Dep Cowan originally responded to the residence on that date at 8:29am. Dorian was not present. His father advised he should be home within a few hours. At 10:07am on that same date Dorian called Flagler County Communications and advised he was at the above listed address. Dep Cowan responded and made contact with Dorian.

A review of Dorian's registration shows that his original conviction was for a violation of Florida State Statute (FSS) 800.04(3) Lewd Assault/Sexual Battery on a person less than 16. He was adjudicated on 9/2/99. He has a subsequent conviction for Unlawful Sexual Activity with Certain Minors (FSS 794.05(1)) and he was adjudicated on 8/22/11.

A search of the Driver and Vehicle Information Database (DAVID) shows that Dorian Coppedge lists 41 Louisiana Dr, Palm Coast, FL 32137 on his driver's license. He was originally issued this driver's license on 10/6/00. The license was last replaced on 5/26/15. According to DAVID records, Dorian began listing the address on 6/29/12, and has not changed his address since. Also, according to DAVID records, Dorian has one vehicle registered to him, a silver 1987 Volvo bearing Florida tag # I954QL and a Vehicle Identification Number (VIN) of YV1AX8849H1220923.

### Surveillance at 41 Louisiana Dr

On 11/23/15 at about 10:10am, I placed a camera in a position, facing 41 Louisiana Dr. The camera is equipped with infrared for nighttime shots and is motion activated. It was set to take two (2) pictures every time it was activated. I left the camera in place until 11/30/15 at 2:32am. The camera took 5258 images over that time frame. I reviewed the

images taken by the camera during that period of time. Thanksgiving (11/26/15) is the only date that Dorian's 1987 Volvo is seen. It is observed parking in the median across from the house at 11:27am, and is gone at 5:08pm. Images 2283 and 2284 show what appears to be, an adult black male that fits the description of Dorian. These are the only two images captured by the motion activated game camera that may depict Dorian during the time the camera was in place. They were taken on 11/26/15 at 1:13pm and 1:14pm, during the same time frame that Dorian's 1987 Volvo was on-scene. A beige 2013 4 door Kia bearing FL tag# 8622TJ, registered to Barbara L Johnson (a black female with a date of birth of 11/5/56) at 41 Louisiana Dr is routinely seen at the home in the surveillance photos. A black female, that is most likely Barbara Johnson, is also routinely seen operating this vehicle. A red 1992 Ford pickup truck bearing FL tag # BIG8J is also frequently seen in the surveillance photos. This vehicle is regularly seen with a trailer attached and being and is registered to Lewis Charles Johnson (black male with a date of birth of 5/28/57). Lewis Johnson is regularly seen operating this vehicle. The only other vehicle that is routinely seen at the residence in surveillance photos is a black 1996 Mercedes Benz bearing FL tag # BGF2I. The vehicle is registered to both Lewis and Barbara Johnson. The Scan Disk card that was used to record all 5258 images was submitted into evidence as item # 344.1.

On 12/12/15 I placed the camera back facing 41 Louisiana Dr. The camera was still set to take two (2) pictures every time it was activated.

### Interview with Lewis Johnson (Dorian's Father)

On 12/16/15 at about 8:30am Detective Costello and I travelled to 41 Louisiana Dr for the purpose of conducting an interview with the residents. Upon arrival we made contact with Lewis Johnson.

During the interview Lewis stated the following: Dorian is his son, resides at the residence, and has done so continuously for several years. Dorian had just left that morning for a court hearing in reference to child support at 8:45am. The only vehicle that Dorian ever drives is his 1987 Volvo, which he usually parks in the driveway. Dorian stays at the home most nights and Lewis does not know where Dorian stays on the nights he does not stay at the home. Dorian does not have regular employment, but occasionally works with Lewis mowing yards. Lewis, his wife, and his granddaughter are the other occupants who reside in the home. I asked Lewis to confirm the phone number that Dorian has provided during registration (386-569-6853). Lewis advised that Dorian's phone number actually is 386-569-6854. I recorded this interview and uploaded it to the Records Management System and headed it "Lewis Johnson interview." I also placed a copy of it onto a CD and placed it into evidence as item 344.2.

**More Surveillance at 41 Louisiana Dr**

On 12-17-15 at approximately 11:00pm I removed the camera and reviewed the photos. The camera took 1355 images while it was in place. I reviewed the images. Upon first examination of the images, it appears that Dorian's Volvo may be parked in the driveway on the evening of 12/12/15 and into the morning of 12/13/15. However, I checked when I placed the camera in place on 12/12/15 and the vehicle was actually an older model Mercedes. I was unable to obtain a tag for the vehicle because it may have compromised the operation. Also in image #s 21-156, a plastic bag can be seen covering a broken out passenger side window. Dorian's Volvo is not believe to have a broken out passenger side window. Image #'s 154-170, a subject who loosely fits Dorian's description, is seen near the aforementioned Gray Mercedes with the plastic bag over the window. This subject is not believed to be Dorian. Dorian has a tattoo on his left arm that says "L Johnson" and this tattoo is not visible in any of the photographs. This subject also appears to be the owner/operator of the aforementioned Gray Mercedes with the plastic bag over the window. The aforementioned Gray Mercedes, with the plastic bag over the window, is gone in picture # 172, and it is never seen at the residence for the duration that the camera was in place. Information revealed later in the investigation has shown it is possible the above described vehicle and male could have been Dorian. However, all information obtained during the investigation, to this point, still showed probable cause that Dorian did not in fact reside at 41 Louisiana Dr as he indicated during his registrations. I conducted numerous spot checks of the residence, attempting to locate this vehicle again and possibly obtain a tag, but the vehicle has never been seen at the home since. On 12/16/15 Det Costello and I can be seen arriving at the residence in our Ford Explorer to conduct the interview with Lewis Johnson. I did not observe any other images that appear to be relevant to this investigation. The Scandisk used to capture these images was submitted into evidence as item # 344.3.

**Cell Phone Records**

At this time I believe there is probable cause to show that Dorian Coppedge is in violation of Florida State Statute (FSS) 943.0435(2) by not residing at his primary registered address, possibly providing false information on his driver's license and during registration, and providing false information as to his telephone number. I completed a Court Order for Dorian's cell phone records. The order was signed by the Honorable Judge Walsh and served to Sprint subpoena compliance. The order requested records for both phone numbers that allegedly belonged to Dorian (386-569-6853 and 386-569-6854) from 11-24-15 to present (1-22-16).

On 1-29-16 I received the records. It should be noted the number provided by Dorian

during multiple registrations (386-569-6853) is not a Sprint number, and is in fact a Verizon number belonging to a subject named Larry Beach. I made contact with Larry Beach via telephone and he advised he has had this number for several years and does not know Dorian Coppedge. The number provided by Dorian's father (386-569-6854), is the phone number I received data for from Sprint. The subscriber information is listed as Lucianne Spearmon with a billing address of 302 N ANDERSON ST, BUNNELL, FL 32110. There is a listed email address of [doriancoppedge@gmail.com](mailto:doriancoppedge@gmail.com) in the subscriber information. Dorian has never disclosed this email address during any of his registrations. The account was established on 2-4-15. It should also be noted that the phone number 386-569-6854 was never provided by Dorian during registration until 1-29-16 when Dorian provided the following phone numbers; 386-569-6854, 386-569-6853, and 386-569-6894. A records search showed that 386-569-6894 belongs to a female named Lynn Schmidt.

Det Jorge "Gabe" Fuentes assisted me in analyzing the Sprint Tower records. Upon reviewing the phone records, Det Fuentes noticed that the cellular phone was frequently using a cellular tower in Bunnell, Florida during the evening hours. I provided Dorian's vehicle description (1987 Volvo bearing Florida tag # I954QL) to Det Fuentes. Based on the cellular phone records and the vehicle information Det Fuentes believed it was likely Dorian was residing in the area of the Bunnell Housing Authority. The Sprint tower records have been uploaded to the RMS and labelled "Dorian Sprint Tower Records". They were also placed onto a CD and placed into evidence as item # 344.4.

Det Fuentes checked the area and subsequently located Dorian's vehicle in the driveway between 309 and 307 South Chapel Street, Bunnell, Florida, 32110. Det Fuentes also checked with the Housing Authority Office and was advised, 309 S Chapel St was leased to Lucianne Spearmon. This is the same name as the phone number provided by Dorian's father for Dorian. Parked directly next to Dorian's vehicle was a vehicle registered to Lucianne (a turquoise 1992 Oldmobile bearing FL # G513QG).

I conducted several spot checks of 309 S Chapel St between the dates of 2-6-16 and 2-15-16. I observed Dorian's vehicle, and took pictures of it, parked at 309 S Chapel St on the following dates and times:

- 2-6-16 at 6:39 pm
- 2-7-16 at 10:52 pm
- 2-8-16 at 12:56 am
- 2-14-16 at 7:37am
- 2-15-16 at 10:37am

Each of the above listed photos have been uploaded into the RMS and labelled as they are above. I also placed them onto a CD and placed them into evidence as item # 344.5.



On 2-19-15 at about 11:51 am Dep Meehan, Dep Robert Finn and I observed Dorian riding a beach cruiser type bicycle in front of the Flagler County Sheriff's Office Operations Center located at 901 E Moody Blvd, 32110. According to Google maps this is approximately .3 miles from the address Dorian is believed to be residing at (309 S Chapel St, Bunnell, FL 32110) and approximately 11 miles away from the address Dorian claims he resides at (41 Louisiana Dr, Palm Coast, FL 32137) on his sex offender registration. Making it significantly more probable that Dorian had been riding his bike from the Chapel St location instead of the Louisiana address. At that time Dep Meehan and I both began to follow and make a series of video recordings of Dorian riding the bicycle. Dorian rode his bicycle to the Flagler County Health Department, located at 301 Dr Carter Blvd, Bunnell, FL 32110. I obtained video of him in this location. I then departed the area and took up a position in view of 309 S Chapel Ave to try to obtain video of Dorian returning on his bicycle to the above listed location. Dorian had become extremely suspicious of our presence at this point and I had to conceal myself in a residence to try to avoid detection. I observed Dorian ride the bicycle a block behind 309 S Chapel, cut through the yard, park the bike in the yard of 309 S Chapel and go inside the home. Dorian then emerged from the home a few minutes later, sat on the front porch area for several minutes, then sat on the aforementioned bicycle in the yard of 309 S Chapel, conversing with an unidentified black male. I video-taped this, but due to a screen and shadows the videos are of very poor quality. Dep Meehan also was able to obtain a short video of Dorian sitting at the above listed address. All videos from this date were placed onto a DVD and submitted into evidence as item # 344.6.

On 2-22-16 at about 8:00 am I conducted a spot check of the S Chapel St address and Dorian's vehicle was no longer on scene. On that same date at 4:44pm, I located Dorian's vehicle parked at his parent's address (41 Louisiana Dr). I took a picture of it at this location, uploaded it to the RMS and labeled it Dorian 2-22-16 4:34 pm.

On 2-23-16 at 9:02 am I observed Dorian's vehicle at 41 Louisiana Dr, took a picture of it, uploaded the picture to the RMS and labelled it Dorian 2-23-16 9:02 am.

On 2-24-16 at 6:31 am I observed Dorian's vehicle parked back at 309 S Chapel St. I took a photograph, uploaded it to the RMS and labelled it Dorian 2-24-16 6:31 am.

On 2-25-16 at 8:08 am I had Dep Hristakopoulos drive by 41 Louisiana Dr, photograph the vehicles in the drive (Dorian's vehicle was not present). I uploaded this photo into the RMS and labelled it Dorian 2-25-16 8:08 am. On this same date at 8:13am I drove by 309 S Chapel St, and photographed Dorian's vehicle parked there. I uploaded this photo into the RMS and labeled it Dorian 2-25-16 8:13 am. The following photographs were also placed
