Upon arrival to 15 Pope Lane, contact was initially attempted at the front door. After multiple failed attempts, deputies conducted a perimeter check. Deputies located a male sitting on the back patio scrolling on his cell phone. Deputy Wolfe called to Chad by his name to which he responded. Chad stood up with his hands up and walked towards Deputy Wolfe. Chad was secured in handcuffs. While Chad was being secured he spontaneously uttered "it's in my pocket down there, it's my friends and he gave it to me to hold".

A black, .380 caliber, semi-automatic, handgun was located concealed in Chads front left pants pocket. A baggie containing 17.9 grams of marijuana was located in Chads kangaroo pocket.

Chad is 20 years old and did not possess a valid concealed carry permit. Chad was read his Miranda rights off of a department issued card. Chad invoked his rights and did not wish to speak to deputies. Chad was searched and placed into the rear prisoner compartment of my marked patrol vehicle.

David provided the Flagler County Communications Center with screenshots of the messages that Chad sent. The messages show Chad clearly stating "I'll find you" "I promise" "You're dead".

These messages will be uploaded to the Aegis case file for review. It should be noted that the firearm in the text messages matched the description of the firearm that was located in Chad's possession.

Chad was placed under arrest for Written threats to kill, Possession of Marijuana 20 grams or less, and Concealed carry without permit. Chad was transported to the Flagler County Inmate Facility without incident.

Chad's iPhone, the marijuana, and the firearm will be submitted into evidence.

Axon body worn camera utilized and will be uploaded to evidence.com.
