Steps to consider:

- The parent/resident may request a conference with the principal or principal's designee and the school media specialist to discuss the material.
  - a. Throughout the process, it is critically important that library workers remain calm, respectful, and courteous. There is no reason to become defensive when a complaint is made. Not only is this counterproductive, but it negates the library's effort to encourage stakeholder involvement. Use the "How to respond to informal concerns" resource as a guide in meeting with the complainant.
  - b. The complainant will be provided with the District's policy for the selection of media materials. The principal or designee and media specialist will provide information about the material in question and answer questions from the individual.
- If the issue is not resolved at the conference, the complainant will be provided with the official "Objection to Media Material" Form to be filed with the school principal and an explanation of the process to follow.
  
- School-level Appeals
  1. A committee of teachers, educational media specialists, and other qualified personnel shall be appointed by the principal to evaluate the challenged materials and to make recommendations of any changes. The principal shall notify the Superintendent and the instructional materials coordinator when a committee is convened.
  2. Challenged materials shall not be removed immediately; however, such materials shall not be available for student use pending a final decision.
  3. Challenged materials shall be read and re-evaluated by the committee, considering the specific objections raised. Using the Media Review Evaluation Form to guide the conversation, the committee shall report its decision within fifteen (15) working days.
  4. The complainant shall be informed in writing concerning the committee's recommendations.
  5. The Principal shall notify the Director of Teaching and Learning of the committee's recommendations
