Upon arrival, Deputy Malheiros had the suspect Noble secured in handcuffs. Noble appeared to have a laceration to his forehead. Deputy James Miley assisted Deputy Malheiros by checking Noble for additional weapons. I located an assault rifle and two hunting type knives at the scene.

I made contact with Joshua Ortiz (witness) who is an employee at Mezzaluna which is located next door to Europa. Ortiz stated he was working in the kitchen area of the restaurant when he saw Noble enter through the back door. Ortiz stated Noble had a "military style gun pinned to his chest". Ortiz stated Noble approached him and said "next fucking room". Ortiz stated he was confused by the comment and Noble said the same thing a second time. Based on other witness statements the following then occurred:

Noble entered Europa dressed like "Rambo" and confronted at least two men in front of Europa. Vassili Mironov (victim) and Roman Dubinsechi (victim) made contact with Noble in an effort to stop Noble from whatever he was planning to do. Noble allegedly displayed the rifle at Mironov, Dubinsechi and other patrons. Mironov and Dubinsechi, made an effort to disarm Noble by "grabbing the barrel of the rifle and pointed it toward the ground". Based on witness statements, the rifle was fired one to two times striking the ground.

Noble then displayed at least one knife and "attacked Mironov" striking him in his left eye (possibly puncturing his eye). Mironov also sustained severe lacerations to both his left and right hands. Mironov was transported to Halifax in Daytona Beach, Florida due to the extent of his injuries. Mironov may possibly have to endure surgery and may have permanent injuries. Dubinsechi assisted Mironov with apprehending Noble. At the time of this report, Dubinsechi's injuries were unknown due to Dubinsechi refusing treatment at the scene. Dubinsechi did sustain moderate lacerations to one of his arms.

Recorded interviews were conducted with the following victim/witnesses at ISD by Cpl. Koep.

Tiffany Burckhalter (owner of Europa) stated that Noble and Steven Hensel entered her bar at approximately 7 PM. Tiffany described Noble and Hensel as friendly and having a good time while consuming alcohol. Tiffany stated that at approximately 930 PM Noble father came into Europa and he and Noble talked outside for a few minutes. When Noble came back in Tiffany stated his demeanor changed drastically and was now angry and easily agitated. Tiffany stated that his father just gave him horrible news and told her that his father just told

him he his dying. It should be noted that Noble's father was interviewed and stated that he did not tell this to Noble and that they had a pleasant conversation. At that point Tiffany stated that Noble attempted to start arguments with other patrons in the bar before eventually leaving. At approximately 1130 Tiffany stated that she observed Noble walk through the bar wearing "Rambo type clothing" with a gun draped over his shoulder. Tiffany followed Noble outside where he confronted the subjects sitting at the table. Tiffany observed Vassili grab the gun and that is when she stated a shot was fired and debris hit her legs from the sidewalk. Tiffany stated that several male subjects tackled Noble but before doing so she observed Noble pull a knife from his back area. Tiffany stated that is when she observed a lot of blood.

Sergey Mislusky (patron), Tatyana Mikheyeva (patron), Olekasnder Nikolayev (patron) were all at Europa Bar socializing at the outside table closest to the bar entrance when they observed Noble wearing dark clothing approach there table and say "I will kill you all" and "now do you have something to say". At that point victim Vassili attempted to grab the gun and along with Sergey and Olekasnder and other patrons wrestled Noble to the ground.

An interview was also conducted with Steven Hensel (friend of Noble) at ISD by Det. Erlandson. Hensel stated that while at Europa with Noble that Noble and a "Russian" had words. Shortly after that they left the bar and went home. When they arrived home Hensel observed Noble putting on fatigues and left the residence. Hensel sent Noble the following text message "Brother lets handle this hand to hand your going to go jail for the rest of your life don't do this". This text was sent at 2306 hours on 3/15/14. Noble did not reply to that message.

Noble was treated for minor injuries at FHF and transported to FCIF.
