4/13/2022 (HAGAN) @7:51 PM RECEIVED A CALL FROM FCSO REGARDING THE REPORT OF A DOG VS DOG INCIDENT, WHICH TOOK PLACE AT HOLLAND PARK. PER THE DEPUTY, NO PERSONS WERE BITTEN AND THE INJURIES SUSTAINED WERE MINOR, HOWEVER THE VICTIM PARTY WANTS TO TAKE THEIR DOG TO THE VET TO BE SAFE. I INFORMED THE DEPUTY TO ALLOW BOTH PARTIES TO TAKE THEIR ANIMALS TO THE VET IF THEY WISH AND OBTAIN THEIR INFORMATION SO THAT I COULD FOLLOW UP IN THE MORNING. THE DEPUTY STATED HE WOULD EMAIL ME ALL OF THE INFORMATION AND ADVISED THEIR CASE NUMBER IS #22-33166.

4/14/2022 @12:25 PM MYSELF AND ACO PRIESTAP RESPONDED TO 56 WASSERMAN DRIVE TO MEET WITH EDWARD DANKO (AGGRESSOR DOG OWNER) REGARDING THE DOG VS DOG INCIDENT, WHICH OCCURRED LAST NIGHT AT HOLLAND PARK DOG PARK. UPON ARRIVAL, MYSELF AND ACO PRIESTAP OBSERVED DANKO AND A FEMALE IN A VEHICLE ABOUT TO PULL OUT OF THE DRIVEWAY OF #56 WASSERMAN DRIVE. I WAS ABLE TO FLAG DANKO DOWN PRIOR TO HIM LEAVING THE DRIVEWAY AND INFORMED HIM OF THE REASON FOR MY VISIT. I ASKED HIM FOR HIS ACCOUNT OF EVENTS REGARDING THE INCIDENT, TO WHICH HE STATED THAT A GROUP OF DOGS WERE PLAYING ROUGH IN THE PARK WITH ONE ANOTHER AND NO ANIMALS WERE BITTEN. DANKO STATED THE OWNER OF THE DOBERMAN BECAME HOSTILE WITH HIM AND STARTED YELLING PROFANITY TO THE POINT DANKO FELT THAT HE NEEDED TO CALL LAW ENFORCEMENT WHICH HE DID. I INFORMED DANKO THAT I HAD OBTAINED ALL OF THE EVIDENCE FROM FCSO TO INCLUDE BODY WORN CAMERA FOOTAGE, AS WELL AS THE POLICE REPORT AND WAS ABLE TO REVIEW SURVEILLANCE FOOTAGE FROM THE PARK, WHICH CLEARLY DEPICTS THE INCIDENT UNFOLD. DANKO WAS EXTREMELY UNCOOPERATIVE WHEN I WAS EXPLAINING THE TEN DAY QUARANTINE PROTOCOL AND STATED HE IS NOT SIGNING ANYTHING AND WILL FIGHT THIS BECAUSE HIS DOG DID NOT BITE ANYONE. ACO PRIESTAP INFORMED DANKO THAT THIS INCIDENT HAD ALREADY BEEN DISCUSSED WITH BARBARA GROSSMAN AND JASON DELORENZO ON HOW THIS CASE WOULD BE HANDLED. ACO PRIESTAP PROVIDED DANKO WITH A BLANK STATEMENT FOR HIM TO COMPLETE, AT WHICH POINT DANKO STATED HE HAD TO LEAVE FOR A PODCAST AND BECAME MORE HOSTILE AND ATTEMPTED TO DRIVE OFF ALMOST RUNNING OVER MY FOOT. DANKO QUICKLY STOPPED AND TRIED TO ARGUE THAT I WAS NOW CLAIMING HE RAN OVER MY FOOT, TO WHICH I REPLIED I DID NOT STATE THAT, HOWEVER, HE WOULD HAVE, HAD HE NOT STOPPED FROM TRYING TO DRIVE OFF IN AN AGGRESSIVE/AGITATED MANNER. AFTER DANKO LEFT THE SCENE I CONTACTED BARBARA GROSSMAN AND NOTIFIED HER OF WHAT TOOK PLACE. AT THIS TIME DANKO HAS NOT SIGNED A QUARANTINE AGREEMENT NOR HAS HE PROVIDED ANY PROOF OF VACCINATION HISTORY FOR HIS ANIMAL/ANIMALS AND NO ANIMALS ARE LICENSED WITH THE CITY AT HIS RESIDENCE.

424-4783 AT HIS RESIDENCE AND OBTAINED HIS ACCOUNT OF EVENTS. ATILES STATED HE CLEARLY OBSERVED A HUSKY MIX TYPE DOG WHT/BLK IN COLOR WITH SLIGHT BROWN ON ITS REAR END AND BRIGHT WHITE EYES, WHICH BELONGS TO DANKO ATTACK AND BITE HIS 1 YEAR OLD DOBERMAN "ANUBIS" ON HIS BACK SEVERAL TIMES CAUSING MULTIPLE MINOR PUNCTURE WOUNDS, WHICH BROKE THE SKIN. ATILES SELF TREATED THE WOUNDS AS HIS PARTNER IS A VET TECH AND THE INJURIES WERE NOT SERVERE. ATILES STATED DANKO WAS EXTREMELY HOSTILE AND GOT IN HIS FACE AT ONE POINT, WHICH IS WHEN DANKO PROCEEDED TO REPORT ATILES TO FCSO. ATILES COMPLETED A SWORN STATEMENT AND EMAILED ME THE RABIES CERTIFICATE FOR "ANUBIS", WHICH SHOWS HE IS CURRENT UNTIL 6/16/2022. ATILES ALLOWED ME TO MEET "ANUBIS", WHO WAS EXTREMELY FRIENDLY AND SHOWED NO SIGNS OF AGGRESSION. I WAS ABLE TO SEE THE FRESH PUNCTURE WOUNDS TO THE BACK OF "ANUBIS" AND TOOK SEVERAL PHOTOGRAPHS. ATILES INQUIRED AS TO HOW HE COULD OBTAIN ALL OF THE CASE INFORMATION, WHICH IS WHEN I INSTRUCTED HIM ON TO HOW TO SUBMIT A PUBLIC RECORDS REQUEST AT CITY HALL. ATILES STATED HE WOULD LIKE TO SEE THE SURVEILLANCE FOOTAGE FROM THE PARK, WHICH I INFORMED HIM WOULD BE INCLUDED IN THE REQUEST.

4/18/2022 (HAGAN) ACO PRIESTAP MADE CONTACT WITH THE FCSO RECORDS DEPARTMENT VIA EMAIL REGARDING OBTAINING COPIES OF SWORN STATEMENTS AND BODY WORN CAMERA FOOTAGE, ALL OF WHICH WAS PROVIDED TO ANIMAL CONTROL. MR. DANKO CAME TO CITY HALL AND COMPLETED THE QUARANTINE PAPERWORK, GAVE US A COPY FROM SAFEHAVEN VETERINARY HOSP. AND LICENSED "MARSHAL" WITH THE CITY. DANKO PROVIDED THE CITY WITH A COPY OF A WELLNESS EXAM HE HAD FOR "MARSHAL" HOWEVER IT DID NOT STATE IF THE RABIES VACCINE WAS CURRENT OR EXPIRED. STAFF CONTACTED SAFE HAVEN VET. HOSP. WHERE "MARSHAL" HAD BEEN PRIOR AND OBTAINED A COPY OF HIS UP TO DATE RABIES VACCINATION RECORDS.

4/25/22 (ER) ATTEMPTED TO CONTACT MR. DANKO AND LEFT VOICE MESSAGE TO RECEIVE A RETURN CALL. MR. DANKO RETURNED MY CALL AND ADVISED THE K-9 IS OK . PER K HAGAN, "MARSHAL" WAS RELEASED FROM QUARANTINE AND CASE WAS CLOSED.
