Spicer was outside of the residence in his vehicle with multiple unknown passengers. Cameron stated that he told Amy and his girlfriend, Caitlyn McMurray, to stay in the residence while he went out and talked to Jacob. Cameron then explained that when he exited the residence his saw De'Coda Ward sitting in the black chair located on the porch to the residence.

Cameron immediately asked De'Coda what he was doing at his house and told him, "I don't fuck with you." Cameron then explained he told De'Coda to leave the residence at which time De'Coda then stood up and raised his fist in a fighting stance. According to Cameron De'Coda then came at him in an aggressive manner which caused Cameron to push De'Coda away. Cameron stated that De'Coda then struck him on the right side of the face with a closed fist. Cameron stated that he then returned a punch which landed on De'Coda right side of his face.

Cameron then stated that De'Coda grabbed Cameron by the waist and threw him over a metal railing to the front porch. Cameron stated he landed on top of De'Coda at which time he felt someone on his back punching him in the back of the head. Cameron then stated he heard his mother yelling, "Why are you pointing a gun at my son and that she was calling the cops." Cameron explained that everyone then separated and De'Coda, Jacob and Jesse retreated back to Jacob's white Chevrolet SUV. Cameron showed me a small cut to the bottom of his foot that he stated he got when he was thrown over the metal railing. Cameron refused medical attention at this time. Cameron filled out a sworn written statement and stated that he wished to pursue charges at this time.

I then made contact with Amy Pearson. Amy explained that she went to the RaceTrac gas station and when she returned home she recognized Jacob Spicer's vehicle parked in the driveway. Amy explained that she went inside the residence and told Cameron that Jacob was outside. While inside Amy began to hear commotion on the porch and exited the residence. Amy stated that she witnessed Cameron and De'Coda fighting and Jacob on top of Cameron's back striking him in the head. Amy then stated that she also saw Jesse Fisher standing over Cameron pointing what appeared to be a small pistol at Cameron, yelling, "Get the fuck off my boy."

Amy stated that she began screaming at Jesse, "Why the fuck did you bring a gun to my house?" Amy explained that Jesse and the other two retreated back to the vehicle at which time she told them she was calling the cops.

When I asked Amy to describe the gun, Amy stated that she did not get a good look at the gun and was not exactly sure it was a gun to begin with. Amy stated that she thought it was a gun because of the way Jesse was holding whatever he had in his hand and due to previous incidents where she believed Jesse to have a gun. I also spoke to Caitlyn McMurray who is Cameron's girlfriend. Caitlyn confirmed Amy's accounts of the incident and stated that she exited the residence at the same time that Amy did. Caitlyn did not have anything further to add at this time.

While interviewing the parties at 12 Fern Ct, a be on the lookout was issued by Flagler Communications for an older model white Chevrolet Suburban SUV owned by Jacob Spicer. Deputy Williams was able to find Jacob Spicer's vehicle parked in front of 48 Leidel Ln, which is Jesse Fisher's residence. Deputy Williams proceeded past the vehicle, notified Flagler Communications, and waited for an additional Deputy. Deputy Williams then noticed the vehicle pass him on Leidel Drive at which time an investigative stop was initiated in front of 11 Lee Dr, Palm Coast FL 32137.

Deputy Williams and Deputy Cochran were able to make contact with De'Coda Ward and Jacob Spicer. Jacob was identified by his Florida driver's license whereas De'Coda was identified by his booking photo through Aegis. De'Coda and Jacob both explained that they went over to Cameron's house due to Cameron owing them money for a skateboard. Both stated that when Cameron exited the residence Cameron saw De'Coda and stated, "I don't fuck with you." However; De'Coda stated that Cameron then picked up a pair of gardening sheers and swung it at De'Coda's face. De'Coda stated that he blocked strike with his forearm but part of the gardening sheers caused a small laceration underneath his left eye. The cut underneath De'Coda's left was extremely minor and bruising was beginning to show around De'Coda's eye consistent with a punch and not being hit with sheers.

Jacob confirmed De'Coda's account of the incident and stated that he never punched Cameron. Jacob explained that his only involvement was trying to get Cameron off of De'Coda after they went over the railing. Jacob gave consent to the search of his vehicle to Deputy Cochran. Deputy Cochran then searched Jacob's vehicle for the alleged firearm that was used during the incident but did not find any such weapon at this time. At this time De'Coda and Jacob were both arrested for simple battery. During a search incident to arrest Deputy Williams discovered a metal pipe in De'Coda's front pocket with burnt cannabis residue inside. De'Coda
