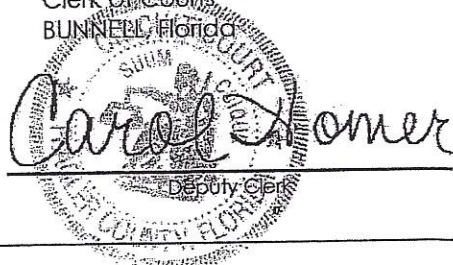
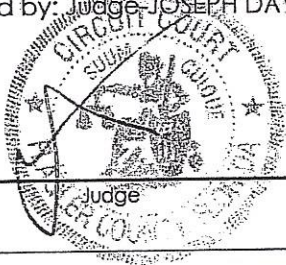

ADVISED THAT THE DEF. FLED THE AREA IN A DARK COLORED CREW CAB PICK UP TRUCK. A B.O.L.O. WAS THEN ISSUED TO AREA UNITS TO LOOK FOR THE DESCRIBED VEHICLE. AT 1842 HOURS, CONTACT WAS MADE WITH THE VICTIM QUESINBERRY AT HIS RESIDENCE AT WHICH TIME, HE ADVISED THAT THE DEF. BELIEVES HE THE VICTIM IS ENGAGED IN AN AFFAIR WITH THE DEF'S WIFE. THE VICTIM DETAILED THIS INCIDENT IN A WRITTEN SWORN STATEMENT ADVISING THAT THE DEF. PULLED UP IN FRONT OF HIS RESIDENCE IN THE DESCRIBED VEHICLE. THE VICTIM THEN EXITED HIS RESIDENCE IN AN ATTEMPT TO IDENTIFY WHO WAS OUTSIDE HIS RESIDENCE. IT WAS AT THIS TIME THE DEF. EXITED HIS VEHICLE AND BEGAN TO APPROACH THE VICTIM. THE VICTIM ADVISED THAT THE DEF. MADE SEVERAL THREATENING STATEMENTS. "DO YOU WANT DRAMA MOTHERFUCKER? I'LL GIVE YOU DRAMA. COME OUT OUT HERE. YOU THINK YOU'RE SO FUCKING TOUGH? I'LL SHOOT YOU DEAD MOTHERFUCKER." VICTIM QUESINBERRY ADVISED THAT DEF. DEL BUONO IS A FLAGLER COUNTY SHERIFF'S OFFICER AND WAS WEARING HIS "GREEN FATIGUE" UNIFORM AND HAD HIS HAND ON HIS WEAPON DURING THE ENTIRE VERBAL THREAT. VICTIM QUESINBERRY ADVISED THAT THE FACT THAT THE DEF. HAD HIS DUTY WEAPON ON HIS PERSON IN PLAIN SITE AND THAT FACT THAT HE THREATENED TO KILL HIM IN SUCH AN AGGRESSIVE MANNER, HE RETREATED TO HIS RESIDENCE BELIEVING HIS LIFE WAS IN DANGER AND DIALED 911.

AT 1843 HOURS FLAGLER COUNTY SHERIFF'S, SGT. G. TIETJE AND DEP. J. FRESHCORN ADVISED THAT THEY BELIEVED THEY HAD THE DEF. AND THE DESCRIBED VEHICLE STOPPED AT SR 100, OLIVE GARDEN RESTAURANT.

AT 1855 HOURS, MYSELF AND OFF. DOYLE RESPONDED TO SAID LOCATION FOR THE PURPOSE OF CONTINUING THE INVESTIGATION. UPON ARRIVAL CONTACT WAS MADE WITH SAID SHERIFF'S DEPUTIES AS WELL AS THE DEF. THE DEF. WAS ADVISED HIS MIRANDA WARNINGS FROM A DEPARTMENT ISSUED MIRANDA CARD AT WHICH TIME; THE DEF. WAIVED HIS RIGHTS AND AGREED TO TALK ABOUT THE INCIDENT.

THE DEF. WAS OBSERVED TO BE WEARING A PAIR OF DARK GREEN "BDU" STYLE TACTICAL PANTS, A BLACK T-SHIRT AND BLACK BOOTS. THE DEF. THE VICTIM'S PLACE OF EMPLOYMENT IS LOCATED AT THIS LOCATION, A MIXED MARTIAL ARTS TRAINING FACILITY. THE DEF. ADVISED HE WAITED IN THE PARKING LOT UNTIL 1830 HOURS FOR THE VICTIM HOWEVER; HE NEVER ARRIVED. THE DEF. ADVISED THAT HE THEN DROVE DIRECTLY TO THE VICTIMS RESIDENCE AT 168 N. PALMETTO AVE. THE DEF. ADVISED THAT AS HE PULLED UP TO THE VICTIMS HOUSE "THE LIGHTS OF MY TRUCK SHINED INTO HIS FRONT DOOR." THE DEF. ADVISED THAT HE STOPPED HIS VEHICLE RIGHT AT THE EDGE OF VICTIMS DRIVEWAY AT WHICH TIME; THE VICTIM EXITED HIS HOUSE AND APPROACHED HIM. I ASKED THE DEF. TO TELL ME WHAT WAS SAID AT THAT TIME BY EITHER SUBJECT. THE DEF. WAS VISIBLY SHAKEN AND COULD BE OBSERVED TREMBLING AS HE INFORMED ME THAT HE COULD NOT REMEMBER WHAT WAS SAID BY EITHER PARTY. I ASKED THE DEF. AGAIN WHAT WAS SAID SO I COULD UNDERSTAND WHAT THE INCIDENT WAS ABOUT. THE DEF. ADVISED I JUST WANTED HIM TO STAY AWAY FROM MY WIFE AND FAMILY WHILE EXPLAINING THAT HE AND HIS WIFE WERE ATTENDING CHRISTIAN COUNSELING. THE DEF. AGAIN ADVISED THAT HE COULD NOT RECALL WHAT WAS SAID AND CONTINUOSLY LOOKED DOWN AND AWAY WHEN PRESSED ABOUT THE CONVERSATION AND HIS REASON FOR BEING AT THE VICTIMS RESIDENCE. THE DEF. WAS CLEARLY UPSET AND REMAINED SHAKEN BY THE INCIDENT. I ASKED THE DEF. IF HE WAS WEARING THE CLOTHES HE HAD ON AT THE TIME OF OUR CONVERSATION WHEN HE WAS SPEAKING TO THE VICTIM. THE DEF. ADVISED YES. I ASKED IF HE HAD BEEN WEARING HIS UNIFORM SHIRT ALONG WITH HIS DUTY BELT AND DEPARTMENT ISSUED FIREARM. THE DEF. DENIED WEARING THOSE ITEMS. I INFORMED THE DEF. THAT THE VICTIM WAS ADAMANT THAT HE THE DEF. WAS IN FULL UNIFORM WITH FULL DUTY BELT AND FIREARM AT THE TIME OF THIS INCIDENT. THE DEF. DENIED THIS ALLAGATION HOWEVER; THE DEF. CONFIRMED THAT HIS UNIFORM SHIRT AND DUTY BELT WERE IN HIS TRUCK WHICH WAS CONFIRMED BY SGT. TIETJE. THE DEF. DESCRIBED THAT HIS UNIFORM SHIRT WAS EMBROIDERED WITH HIS NAME AND BADGE ON IT.

THE VICTIM QUESINBERRY ADVISED THAT THE NEIGHBOR JUST A DOOR AWAY CAME OUT OF HIS RESIDENCE AT THE TIME OF THIS INCIDENT AND MAY HAVE WITNESSED A PORTION OF THIS INCIDENT. CONTACT WAS MADE WITH MR. WILLIAM WORTMAN AT 163 N. PALMETTO AVE. MR. WORTMAN CONFIRMED THAT HE DID SEE THE TWO MEN NEAR THE VICTIMS FRONT DOOR BUT DID NOT OBSERVE ANY TYPE OF ALTERCATION OR ARGUMENT. WORTMAN ALSO OBSERVED A LARGE DARK VEHICLE AT THE FRONT OF THE RESIDENCE. THIS CASE IS BEING FORWARDED TO THE STATE ATTORNEY'S OFFICE FOR THEIR REVIEW NO FURTHER ACTION BY THIS OFFICER




